Dear Members of the Board:

The Sheriff's Office, Patrol Division, has requested Seaside Company the use of a Beach Street parking 1 ot to conduct "low speed" driver training on January 13/27, 1999.

The Sheriff's Office lead trainer is certified by Peace Officer Standards and Training (P. O. S. T.) to conduct the driver training. The lead instructor will be assisted by other Sheriff's Office instructors at the training site.

The Beach Street parking area is large enough to allow for cone patterns necessary for the training. All training will be done at "low speed", minimizing hazardous conditions. All participants in the training will be closely supervised and precautions will be undertaken to minimize the risk of personal injury or property damage.

The Seaside Company requires a "hold harmless" agreement in order for the Sheriff's Office to train on company property. County Counsel has prepared such an agreement for your Board's review and approval. This agreement is attached to this letter.

HOLD HARMLESS AGREEMENT SEASIDE COMPANY

The County of Santa Cruz has requested permission from the Seaside Company to use its parking lot, located at Beach Street and 3rd Street, Santa Cruz, to conduct driver training.
