LANDSLIDE HAZARD MITIGATION PROGRAM AND GEOLOGIC HAZARD ABATEMENT

DISTRICTS

Members of the Board:

On November 24, 1998 your Board directed the Planning Department to report back on today's agenda with program recommendations related to the Landslide Hazard Mitigation Grant Program.

We have only today received the final grant approval letter from the Governor's Office of Emergency Services (OES) and have had not yet been able to review detailed program requirements. However, we have already discovered several issues which will require further clarification from OES before we can recommend further actions relative to the grant programs.

Nevertheless, without obligating itself to the program requirements from the State, the County can proceed independently with the process to create Geologic Hazard Abatement Districts for completing the acquisition of properties and demolition of structures.

As required by the Public Resources Code, we have attached proposed Resolutions initiating proceedings for the formation of three separate Geologic Hazard Abatement Districts; Corralitos, Mid-County, and Heartwood Hill (Attachments 1, 2 & 3). Associated with each Resolution are three exhibits; a) a Plan of Control - a report describing in detail the geologic hazard, its location and a plan for its mitigation or abatement; b) a map of the proposed District, and: c) a legal description of the boundary of the proposed District.

If, after reviewing these documents, your Board determines that the health, safety and welfare require formation of each District, you may adopt the Resolutions setting a public hearing on the matter for January 12, 1999 and directing the required notice thereof. Objections to the formation of the District may be filed by any owner of real property within the proposed District at any time up to an including the time of the public hearing. If owners of more than 50 percent of the assessed valuation of the proposed District object to its formation, your Board must direct that the proceedings be abandoned. If this does not occur, your Board may adopt a resolution ordering the formation of the district and appointing the initial Board of Directors.

- 1) Adopt the attached Resolutions initiating proceedings for the formation of the Districts and setting public hearings on January 12, 1999 at 9:00 a.m. or thereafter to consider the formation of the Corralitos Geologic Hazard Abatement District, the Mid-County Geologic Hazard Abatement District and the Heartwood Hill Geologic Hazard Abatement District, and;
- 2) Direct the Clerk of the Board to mail appropriate notices to each owner of real property within the proposed District.

#### PLAN OF CONTROL

#### 1. **Introduction**

This Plan of Control includes a description of the geologic hazard; its location; the area affected, and; a plan for the abatement of the hazard to structures in the District.

#### 2. **DESCRIPTION OF HAZARD**

The area of Corraltios subject to landsliding caused by the El Nino storms of 1998, include a large slide complex along Amesti Road (Zone 1) and an unrelated landslide on White Road (Zone 2). Landslides caused by severe El Nino rains caused failure of County roadways and severe damage to homes. Structures have been destroyed, severely damaged or are at imminent risk of being destroyed as a result of continued sliding. All structures have been posted as unsafe to occupy and have had Notices of Geologic Hazard recorded on the property title.

The Amesti and White Road slides are a group of slides in the Corralitos area of southern Santa Cruz County. While geographically close, the slides are very different in character.

The Amesti Slide complex is a group of interconnected slides both physically and by the manner of failure. The actively moving portion of one landslide encompasses approximately fifty acres extending 1,500 feet along the toe of the slope on the east side of Corralitos Creek. Ultimate extent of the sliding and related damage will be an ancillary aspect of the work to dewater the slide mass under DSR 98-00 1.

Earthquakes similar to and larger than the Loma Prieta Earthquake have occurred five times in the last century. If any one of the earthquakes occurred now, it would cause landslide movement resulting in significant additional damage to the structures, roadway and utilities. Roadway damage would likely sever emergency response infrastructure, such as water, making fire suppression and other emergency response difficult of impossible in an area of 60 homes.

Recent sliding has affected a large section of dormant paleolandslides causing a series of 10+ acre or larger earthflows or transitional landslides along the modern hill's toe. The initial failures occurred episodically during wet winters in the mid seventies and eighties, but the large scale landsliding did not reoccur until after the Loma Prieta Earthquake. During the 1989 earthquake, a pattern of ground cracks appeared at what was to become the current "pull away" of the main failure.

The Amesti Road landsliding has not reached equilibrium. At a minimum, the current escarpments will continue to fail and will extend the landsliding up slope potentially damaging additional structures and utilities.

The White Road slide is a rotational block slide' approximately 100 feet in diameter which has failed directly beneath the residence located at 609 White Road. The residence has been severely racked and has been posted has unsafe to occupy and a notice of geologic hazard has been recorded on the property title. This slide is situated approximately 200 feet up slope from two other residences. The slope is approximately 30%. There is a high probability that additional sliding would be initiated by the onset of heavy winter rains.



The slide also destroyed approximately 100 lineal feet of the County roadway. It is likely that the head scarp will continue to migrate up slope with the onset of rains.

3. LOCATION OF THE HAZARDS AND AFFECTED AREAS

Zone 1 - in the Corralitos area of southern Santa Cruz County along the western side of Amesti Road at approximately Mile 2.5 through 2.8.


Zone 2 - in the Corralitos area of southern Santa Cruz County at address 609 White Road


#### 4. PLAN FOR ABATEMENT OF HAZARD

By acquiring these properties, and demolishing structures, the threat to public safety from continued slide movement will be minimized. In addition, County acquisition of these sites will support and expedite repair of the adjoining public roads being conducted under separate Public Assistance DSRs and not a part of the Landslide HMGP. With completion of the acquisition of these properties, the County will be better able to provide for maintenance of the DSR funded road repairs without the need for coordination with private property owners. In the case of the White Road site, acquisition and demolition of the structure followed by the DSR funded repair of the road failure will mitigate damage to residences immediately downslope from the slide which are highly susceptible to catastrophic damage from this slide.

Demolition will remove all construction features and elements, including foundations where they do not contribute to the stability of the site. Septic tanks will be filled with sand. After demolition, sites will be treated with materials to minimize future erosion.

Properties acquired utilizing Federal Emergency Management Agency Landslide Hazard Mitigation Program funds will be maintained in open space or equivalent uses in perpetuity.

# MIDCOUNTY GEOLOGIC HAZARD ABATEMENT DISTRICT PLAN OF CONTROL

#### 1. Introduction

This Plan of Control includes a description of the geologic hazard; its location; the area affected, and; a plan for the abatement of the hazard to structures in the District.

#### 2. Description of Hazard

Four parcels in mid-Santa Cruz County were subjected to landsliding caused by the El Nino storms of 1998, include debris flows (Zone 1) and slope failures (Zones 2 & 3). Structures were damaged or destroyed on four of the parcels and all are subject to future risk from slides.

The Zone 1 slide, consists of two parcels (APNs 087-1 1 1-01 & 087-1 1 1-02), impacted by two slides which destroyed the majority of the structure, leaving only one bedroom intact. There is high probability that the remainder of the slide material will continue to fail with the onset of winter rains.

The Zone 2 slide has been affected by a large slide which has moved to within 10 feet of the building's foundation. With the onset of winter rain, there is a high probability that the slide will continue to migrate up slope, undermining the foundation and destroying the structure.

The Zone 3 slide is at 226 Hayward Drive, starts in mid property and has undermined the foundation of the residence. This slide continues under the home after which it reaches the embankment of Valencia Creek, where the scarp is approximately 40 feet in height. With the onset of winter rains, it is highly probable that the structure will fail catastrophically into the creek bed.


#### 3. LOCATION OF THE HAZARDS AND AFFECTED AREAS


The location of the hazards are; Zone 1 - at 18704 Highway 9 along the eastern side of State Highway 9 in the Boulder Creek area; Zone 2- at 228 Hayward Drive in the Aptos area, and; Zone 3 - at 19320 Hidden Springs Lane in the Boulder Creek area

#### 4. Plan for Abatement of Hazard

The primary means of abatement will be through demolition of structures at risk from further sliding. Demolition will remove all construction features and elements, including foundations where they do not contribute to the stability of the site. Septic tanks will be filled with sand and all utilities will be removed. After demolition, sites will be treated with materials to minimize future erosion.

Properties acquired utilizing Federal Emergency Management Agency Landslide Hazard Mitigation Program funds will be maintained in open space or equivalent uses in perpetuity.

This Plan of Control includes a description of the geologic hazard; its location; the area affected, and; a plan for the abatement of the hazard to structures in the District.

#### 2. **DESCRIPTION OF HAZARD**

Two parcels on Heartwood Hill Road were subjected to landsliding caused by the El Nino storms of 1998. A repetitively active slide has bifurcated Heartwood Hill Road, isolating six residences. The two residences on the active portion of the slide have been gradually pulled apart as the slide has moved downslope approximately 100 feet. There is a high degree of probability that the slide will continue up slope and eventually threaten Highway 236.


#### 3. LOCATION OF THE HAZARDS AND AFFECTED AREAS

The slide affects properties located at 380 & 400 Heartwood Hill Road in the Boulder Creek area of Santa Cruz County.

#### 4. PLAN FOR ABATEMENT OF HAZARD

The primary means of abatement will be through demolition of structures at risk from further sliding. Demolition will remove all construction features and elements, including foundations where they do not contribute to the stability of the site. Septic tanks will be filled with sand and all utilities will be removed. After demolition, sites will be treated with materials to minimize future erosion.

Properties acquired utilizing Federal Emergency Management Agency Landslide Hazard Mitigation Program funds will be maintained in open space or equivalent uses in perpetuity.
