ADOPT RESOLUTION TO IMPLEMENT CLASSIFICATION AND COMPENSATION ACTION

Dear Members of the Board:

The Personnel Department has completed a classification and compensation action requiring your Board's approval.

A classification study for new positions in the Sheriff-Coroner's Department has been completed which recommends the creation of a new class of Sheriff's Community Service Officer. It is recommended that the salary for this class be placed at range E6 (\$2342-3137 monthly). Furthermore, as this is a non-sworn position that will not require the use of a firearm, it is recommended that this position be placed in the General Representation Unit.

Funding for this action is included in the department's budget. The department and employee organization is in agreement with the classification and compensation action described above.

It is RECOMMENDED that your Board:

- 1. Adopt the attached resolution to amend Resolution No. 279-75 to establish the class and add the salary range as described above.
- 2. Designate the class of Sheriff's Community Service Officer as General Representation Unit.
