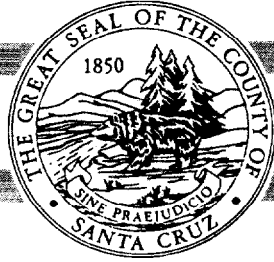

III. BOARD STRUCTURE The Assessment Appeals Board consists of members appointed by the Board of Supervisors, three regular members with staggering terms and an alternate member.


IV. BOARD STAFF The Assessment Appeals Board is staffed by the Clerk of the Board of Supervisors and by County Counsel.

V. ATTENDANCE Two members represent a quorum. An alternate member is available when a regular member cannot attend. See attached attendance sheet.


