

ENVIRONMENTAL HEALTH APPEALS COMMISSION

1998 ANNUAL REPORT

I. ROLE OF COMMISSION

The Commission is directed to receive, process, adjudicate, and issue orders in connection with written appeals from denial, suspension, or revocation of permits issued under authority of the Health Officer. Two appeals were heard during calendar year 1998.

II. MEETING DATES

Upon receipt of an appeal, the Clerk of the Commission sets the matter for hearing not later than twenty business days thereafter.

III. COMMISSION STRUCTURE

The Environmental Health Appeals Commission consists of a County Supervisor appointed by the Board of Supervisors, a person with knowledge of soils or groundwater hydrology appointed by the board; and the Environmental Coordinator of the County Planning Department.

IV. COMMISSION STAFF

The Environmental Health Appeals Commission is staffed by the Clerk of Board of Supervisors and by County Counsel.
