DAVENPORT OLDTOWN SEWER RECONSTRUCTION PROJECT

Members of the Board:

The Davenport County Sanitation District has been placed on the State Revolving Fund (SRF) priority list for a possible loan in the amount of approximately \$185,000 at 2.6 percent interest to partially fund the subject project. This loan, administered by the State Water Resources Control Board (SWRCB), would supplement a 75 percent project grant from the United States Department of Agriculture, Rural Development, which has been approved. This project has received an allocation of funds for planning and design from the SWRCB's Small Communities Grant Program. As part of the SRF application process, the SWRCB requires that your Board adopt a resolution to establish a dedicated source of revenue to repay the SRF loan and a resolution to establish a capital reserve fund. These two resolutions are required to initiate a process by the SWRCB leading to a loan contract for the project.

The loan repayment will be approximately \$12,000 per year for twenty years. It is recommended that sewer service charge revenue and/or Capital Improvement Program (CIP) contributions from Lone Star Cement Corporation be dedicated as the source of revenue. Negotiations with Lonestar regarding CIP contributions, which are associated with their proposed water service connection permit mitigation measures, are expected to be completed soon.

The capital reserve fund requirements state that a minimum of one-half of one percent of the SRF loan (approximately \$925) be deposited into this fund annually for a period of ten years. These funds would come from either sewer service charge revenue or from the Lonestar CIP contributions. All deposits, including interest, shall remain in the fund for the life of the loan contract. At the end of the loan contract, disposition of funds shall be at the District's discretion.

It is therefore recommended that the Board of Directors take the following action:

- 1. Adopt a resolution establishing a dedicated source of revenue to repay the State Revolving Fund.
- 2. Adopt a resolution establishing a capital reserve fund.
