SUBJECT: SAN VICENTE CREEK STREAMBANK PROTECTION PROJECT

Members of the Board:

The rock slope protection segment of the above project has been completed. The project construction had to be divided into two phases to satisfy the requirements of the Department of Fish and Game, which do not allow installing a diversion pipe in the stream this time of year.

Directions and permit conditions by the Department of Fish and Game necessitated doing additional work to construct the access road at a cost of \$6,500. The conditions also required staging the project at a cost of \$17,500. These two extra work items had to be processed as Contract Change Order No. 1, which amounted to \$24,000

In addition, the project had to be winterized in areas where it was not possible to do construction at this time of year. The winterization extra work item had to be processed as Contract Change Order No. 2 in the amount of \$8,400.

Due to the immediate necessity to complete the above work, the Department of Public Works processed Change Order No. 1 in the amount of \$24,000 and Change Order No. 2 in the amount of \$8,400 with the approval of the County Administrative Office. As required by the County's change order policy, we are now bringing these change orders to your Board for ratification.

It is therefore recommended that the Board of Supervisors ratify the attached contract change orders for the San Vicente Creek project.


