Members of the Board:

At the January 12, 1999 Board meeting, bids were received for the 126 Front Street Kitchen Grease Interceptor project. Your Board directed the General Services Department to review bids and return on or before February 2, 1999 with a recommendation for award.

As directed, bids received have been reviewed and we believe that the lowest bidder, Durden Randolph, Inc. with a bid of \$13,800 can accomplish the work to the County's satisfaction.

Sufficient funds are available for this work in the Health Services Agency, index 363 149, sub object 3405 including a ten (10) per cent contingency for change orders if required.

It is therefore RECOMMENDED that your Board:

- 1. Award a contract to Durden Randolph, Inc. for \$13,800; and
- 2. Direct General Services to notify the Contractor and arrange for completion of contract documents; and
- 3. Authorize the Director of Health Services to approve change orders, if required, up to \$1,380; and

- 4. Appropriate \$1,380 in addition to the contract amount to cover change order expenditures, if required; and
- 5. Authorize the General Services Director to sign the contract agreements and associated documents on behalf of your Board.
