Increase Authorization for Personal Computers

Dear Members of the Board:

The Information Services Data Processing Budget includes a blanket authorization for personal computers (PC) on the Four-Year Replacement Program. The authorization allows for purchases to occur which are approved as part of each department's budget.

Additional appropriations are required at this time for the Four-Year PC Replacement Program allocation authorized by your Board during the budget process due to the following reasons: expiration of the 48 month PC Lease Agreement and mid-year Board approval of unanticipated projects.

Expiration of the 48 Month PC Lease Agreement

We started the PC Replacement Program during the 1994/95 fiscal year and the 48 month lease expires this year for the PCs that were purchased during the 1994/95 fiscal year. Departments have the option of continuing on the lease program resulting in new PCs being purchased and installed in their departments. At this point in time, the majority of departments have opted to continue on the lease program and we anticipate that the remaining departments will do the same. Funds have been approved within each department's 1998-99 budget to finance the continuation of the PC leases.

Mid-vear Board Approval of Unanticipated Projects

Several large departments have had projects approved by your Board since the adoption of the Final Budget which require additional PCs to be purchased in order to implement the project.

The Four-Year Replacement Program PC's are funded entirely from customer charges. The funds come from departmental budgets which are approved by your Board. The action recommended here does not have a Net County Cost impact.

It is RECOMMENDED that your Board 1.) Approve changes to the fixed asset list within the Information Services Department and associated budget transfers by increasing the authorization for Four-Year Program PC'S from 150 to 250, with an appropriation of \$235,000, and; 2.) Approve the attached resolution accepting additional customer service fees to account for additional depreciation expense.
