## SUBJECT: COLLECTION OF SEWER SERVICE CHARGES ON THE TAX ROLL FOR THE DAVENPORT COUNTY SANITATION DISTRICT

Members of the Board:

Davenport County Sanitation District Ordinance No. 13, adopted on June 26, 1984, provides for the collection of the District's sewer service charges on each year's tax roll, until June 30, 1999. It is now necessary to amend this ordinance in order to continue with the District's chosen collection method. It is therefore proposed that Ordinance No. 13 be amended to remain in effect until June 30, 2014.

It is therefore recommended that your Board set a public hearing on the adoption, in concept, of this amended ordinance for February 23, 1999, and direct the Clerk of the Board to advertise the attached Notice of Public Hearing in accordance with Government Code.
