RECOMMENDATION OF AWARD: BONNY DOON REPLACEMENT FIRE STATION, 98C1-015

Dear Members of the Board:

As your Board is aware, the General Services Department re-bid the Bonny Doon Replacement Fire Station Project after working with staff from County Fire, the Bonny Doon Fire Company, and Supervisors Wornhoudt's office to reduce the scope of the project. Bids were received by your Board on the reduced scope project on January 26, 1999. Your Board directed the General Services Department to review bids and return on or before February 23, 1999 with a recommendation for award. The low bid from Roger Jones Construction in the amount of \$425,398, exceeded the identified project funding by \$12,000.

In order to proceed with the project, the County Administrative Office and General Services Department have identified additional monies for the project and are recommending that your Board award the project today. The additional funding will be provided as a loan from the Public Facility Retrofit account (Index 194020, Subobject 6610). The loan from the Retrofit account will be repaid over the next two years from rental proceeds received from the residence located on the same property as the replacement fire station. In the event that project contingencies are not fully utilized or found to be necessary, then the loan would be repaid in full. The County Administrative Office and all project participants are in agreement with this approach.

It is therefore recommended that your Board:

- 1. Award a contract to Roger Jones Construction in the amount of \$425,398 for the Bonny Doon Replacement Fire Station; and
- 2. Adopt the Resolution accepting the unanticipated revenue into budget index 194025 and transfer funds in the amount of \$12,000 from budget index 194020, sub-object 6610 (Public Facility Retrofit) to index 194025, sub-object 6610, user code Q99001; and

- 3. Authorize the Director of General Services to notify the Contractor and sign the contract agreements and associated documents on behalf of your Board; and
- 4. Authorize the Director of General Services to approve change orders, and appropriate \$40,000 in addition to the contract amount to cover change order expenditures, if required.
