Please be advised that due to recent changes in the Military and Veterans Code Section 972.1, the total amount of FY **1998/99** county subvention payments statewide have increased by \$500,000.

Accordingly, our previous estimate of Section 972.1 subvention payments to Santa **Cruz** County of \$18,859, has been increased by \$4,834.

Our current estimated Section 972.1 subvention payments to Santa **Cruz** County payable beginning this fiscal year, now total \$23,693.
