
**SUBJECT: COUNTY SERVICE AREA NO. 13, HUTCHINSON ROAD, ZONE B
(DISTRICT 5), RESOLUTION ACCEPTING UNANTICIPATED REVENUE**

Members of the Board:

County Service Area No. 13, Hutchinson Road, Zone B, has solicited proposals for road repair on Lower Hutchinson Road. Based on proposals submitted from various contractors, it appears that the low bid of \$6,527 is greater than current funds available. In order to proceed with this repair, it was necessary for County Service Area No. 13, Zone B, to submit additional revenue in the amount of \$237, which has been received by Public Works from the County Service Area No. 13 representative. Once your Board has accepted the unanticipated revenue, Public Works will submit the proposal package to the Purchasing Department for its review and action.

It is therefore recommended that the Board of **Supervisors** adopt resolution accepting unanticipated revenue in the amount of \$237 from County Service Area No. 13, Hutchinson Road, Zone B.



WHEREAS, the County of Santa Cruz is a recipient of funds from CSA No. 13, Hutchinson Road, Zone B for road repair; and


