#### **Contract Amendment for Construction Services**

Dear Members of the Board:

The Simpkins Family Swim Center and Live Oak Community Center was opened to the public this past fall and since that time, has proved a popular recreational resource to Live Oak and County residents alike.

As we have reported to your Board on several occasions, complex issues arose during the course of construction and have continued during the construction close-out phase of the project. As a result, it is necessary at this time to amend the Agency's contract with TRI-B, the construction management firm for the project, in order to provide for an extension of their services. While it is difficult at this time to determine the level of service that will be needed over the coming months, it is anticipated that the proposed contract amendment, for an amount not to exceed \$10,000.00 will provide the Agency with the services needed through the end of June 1999. The amendment addresses the volume of work that is anticipated during this period of time, ensuring that the necessary project close-out activities occur. Funds are available in the project budget for this purpose. It is estimated that we will recoup these costs through the liquidated damages clause of the construction contract and through other means available to the Agency.

It is therefore RECOMMENDED that your **Board**, as the Board of Directors for the Redevelopment Agency, approve the attached contract amendment with TRI-B for an amount not to exceed \$10,000.00 for additional services for the Simpkins Family Swim Center and the Live Oak Community Center.

#### **AMENDMENT** TO AGREEMENT

The parties hereto agree to amend that ccrtain Agreement dated October 17, 1995, and amended June 18, 1996: June 10, 1997: December 9, 1997; February 3, 1998: April 14, 1998; June 16, 1998; and November 24, 1998, by and between the COUNTY OF SANTA CRUZ REDEVELOPMENT AGENCY and TRI-B, Inc. by adding an amount not to exceed \$10,000 for a total contract amount of \$536,250.

## 1. Services through June 30. 1999:

TRI-B will **provide** for all ongoing project management services related to the **Live** Oak Swim Center for an amount not to **exceed \$10,000**.

2. Hourly Rates: Services will be billed on a time and materials basis at the following rates:

\$75.00 per hour -- Construction Manager \$65.00 per hour -- Technical Analyst \$60.00 per hour -- Field Manager

## 3. Reimbursables:

Any reimbursable expenses will he paid from funds remaining for reimbursable expenses from previous contract amendments.

All other provisions of said Agreement shall remain the same.
