ADOPT RESOLUTION TO ESTABLISH CLASSIFICATION FOR BUDGETED POSITIONS

Dear Members of the Board:

On February 23, 1999, your Board approved the addition of four half-time limited-term Head Lifeguard positions in the POSCS budget and directed staff to classify the positions. The duties and responsibilities of the new positions are consistent with the existing class of Head Lifeguard-Head Instructor. However, this class was established only for extra-help employees. It is now necessary to assign the class to a representation unit to reflect that it can be used for both regular and extra-help employment. It is also necessary to adopt the attached resolution to establish a different salary range for this class now that it is also being used for budgeted positions. The affected employee organization is in agreement with this action.

It is **RECOMMENDED** that your Board:

1. Adopt the attached amendment to Resolution No. 279-75 to change the salary range for the existing class of Head Lifeguard-Head Instructor. No change in hourly rates is entailed.
2. Approve assignment of the class of Head Lifeguard to the General Representation Unit.
