SUBJECT: SANTA CRUZ HARBOR - DIRECTIONAL SIGNAGE

Members of the Board:

The Santa Cruz Harbor has submitted a request to the Department of Public Works to install new directional signage along several County roadways to improve the public's awareness in accessing the Harbor. The new directional signs would provide consistency with the signs currently in use by the City of Santa Cruz in directing traffic to the Harbor and other areas of interest throughout the city. A list of the proposed directional signage locations is included for your Board's review.

The proposed **signage** color scheme was developed through the City of Santa Cruz's Redevelopment Agency, and a sample is included for your Board's review. Since the proposed color scheme for the signs is not recognized as a directional sign color in the State Traffic Manual, the Department of Public Works is submitting the **signage** request through your Board for approval on behalf of the Santa Cruz Harbor.

If your Board approves the Harbor directional **signage** plan, the Department of Public Works is recommending that the signs be purchased and installed by Santa Cruz Harbor through the County encroachment permit process. The County's existing directional signs for the Santa Cruz Harbor would be removed at the time the new directional signs are installed. The encroachment permit for the Harbor signs may also be revoked in the future if or when a future Live Oak Signage Plan is developed by the County Redevelopment Agency.

It is therefore recommended that the Board of Supervisors approve the proposed directional **signage** plan for the Santa Cruz Harbor and direct the Department of Public Works to process the Encroachment Permit for the new Santa Cruz Harbor directional signs.
