SETTING PUBLIC HEARINGS FOR THE ADOPTION OF ANNUAL PARKING MAINTENANCE AND OPERATIONS CHARGES FOR THE SOQUEL VILLAGE PARKING AND BUSINESS IMPROVEMENT DISTRICT

Dear Members of the Board:

Each year, your Board considers the Annual Report of the Soquel Village Parking and Business Improvement Area and adopts the assessment charges for the coming fiscal year. The purpose of this letter is to set the required public hearings and provide the necessary public notice of the proposed parking maintenance and operation charges for the 1999-2000 fiscal year.

The Soquel Village Parking and Business Improvement Area was established for the purposes of providing for business improvements and the maintenance and operation of public parking facilities. As you are aware, of the two benefit zones that were established as part of this process, the business improvement assessments were discontinued, leaving only the parking maintenance and operation charges before your Board for consideration.

In order to adopt the parking maintenance and operation charges for the coming fiscal year, it will be necessary to hold two public hearings, and provide mailed and published notice of the proposed 1999-2000 assessments. The first public hearing is proposed to be scheduled for March 23, 1999. At that hearing, your Board will consider the Annual Report for the improvement area, as well as take public testimony on the proposed parking maintenance charges. The second public hearing on the proposed charges will then take place on April **20,1999**. At the conclusion of that public hearing, your Board will be able to adopt the parking maintenance and operation charges for fiscal year 1999-2000.

It is therefore **RECOMMENDED** that your Board take the following actions:

- 1. Set a public hearing on the proposed parking maintenance and operation charges for the Soquel Village Parking and Business Improvement Area for the 1999-2000 fiscal year for the morning agenda of Tuesday, March 23, 1999;
- 2. Set a second public hearing on the proposed parking maintenance and operation charges for the morning agenda of Tuesday, April 20, 1999; and
- 3. Direct the Clerk of the Board to complete the required notice of the public hearings on the proposed assessment charges.
