**RE:** Purchase of Criminal Fingerprinting Equipment

Dear Members of the Board:

### Backaround: RAN Committee:

On November 18, 1997, your Board adopted Resolution No. 435-97 authorizing an additional vehicle license fee to fund the acquisition, installation and maintenance of automated fingerprint identification equipment. (Attachment A) In so doing, your Board approved the reformation of the Remote Access Network (RAN) Committee for Santa Cruz County. The Remote Access Network is a uniform statewide network of equipment and procedures that allow local law enforcement agencies direct access to the California Identification System (CAL-ID). The CAL-ID is an automated system maintained by the Department of Justice for retaining fingerprint files and identifying latent fingerprints. (Attachment B)

The RAN Committee is a State-authorized county advisory committee responsible for making recommendations to the Board of Supervisors regarding the purchase of equipment, which is compatible with the Department of Justice CAL-ID master plan, funded through State Senate Bill 720.

Membership categories for the RAN Committee are established by the State Penal Code and include a member of the Board of Supervisors; the Sheriff; the District Attorney; the Chief of Police of the department having the largest number of sworn personnel within the County; a second Chief selected by all other Chiefs within the County; a mayor selected by the Mayor Select Committee; and a member-at-large chosen by other members of the RAN Committee. A complete listing of Committee members is attached. (Attachment C)

#### DMV Estimated Funds Available: \$191, 116 in 1999:

Responding to your Board Action of November 11, 1997, the Department of Motor Vehicles (DMV) authored a letter on May 22, 1998, accepting Resolution No. 435-97, as authority to collect the Fingerprint Identification Fee for vehicles registered by Santa Cruz County Residents. (Attachment D) The collection of one dollar per vehicle started with applications made for registration renewals due on or after January 1, 1999, and original registrant applicants due from January 1, 1999 through the time this five-year collection sunsets, December 31, 2003.

The attached DMV chart "Estimated Fee Paid Vehicle Registrations by County" was based on estimated fee paid vehicle registrations in Santa Cruz County (Attachment E). The total estimate for 1999 is 200,180 fee paid registrants. Senate Bill 720 and your Board's Resolution No. 435-97 allows for one dollar per fee paid registrant to be collected and deposited into the County Automated Fingerprint Identification Fund. Revenue expected is \$200,180 less DMV administrative collection fees estimated to be \$.005 per vehicle (approximately \$1,042 the first year), and one-time implementation charge of \$8,022, for a remaining anticipated net revenue of \$191,116, in 1999, Year One of this five-year program.

DMV revenue payments are expected to be made by the DMV to the County Automated Fingerprint Identification Fund, on a quarterly basis, for the purpose of purchasing fingerprint equipment, systems and related expenses as recommended by the RAN Committee and approved by your Board. The first payment is expected to be made midyear, 1999, however the DMV has offered to advance us funding in the form of an interest-free loan pending the implementation of the quarterly payment system.

#### **Evaluation of Equipment Needs:**

The Remote Access Network (RAN) Committee met on February 5<sup>th</sup>, 1999. At this meeting, our office presented the results of a lengthy, county-wide fingerprinting needs assessment (Attachment F). This evaluation was conducted at the request of the RAN Committee during its October 29, 1998 meeting, and was conducted with participation from the Chiefs of Police of Capitola, Scotts Valley, Santa Cruz, University of California at Santa Cruz, Watsonville and the Sheriff. This assessment identified important criminal fingerprinting equipment which is not compliant with Year 2000, and cannot be made compliant, and recommended purchase of replacement equipment with RAN funds.

### <u>Justification for Equipment Purchase:</u>

To address this non-compliant equipment need, representatives of the Sheriffs Office Crime Scene Investigations (CSI) unit gave an informative presentation on current and future latent fingerprinting needs of Santa Cruz County, during the February 5<sup>th</sup> RAN Committee meeting. CSI outlined how criminal investigators rely heavily on latent fingerprint equipment to help identify both suspects and victims of crimes. They emphasized the importance of fast, reliable communication with the Department of Justice during the early hours of an investigation, before the suspect has time to flee or approach a second victim, while there is still time to identify and collect evidence at the undisturbed crime scene.

CSI drew attention to the fact that the only Electronic Verification Only Terminal in the county was not Year 2000 compliant, and was in need of replacement. Without replacement of this equipment, detectives could expect response time to increase to six weeks and beyond. CSI also explained that the addition of a high definition facsimile machine would improve response from the Department of Justice, from several weeks to a matter of hours. The Sheriff's Office requested that funds be used to purchase this equipment, to be housed in the Sheriffs Office Investigations unit, and made available for use by all law enforcement agencies county-wide.

#### RAN Committee Recommendation for Eauioment Purchase:

As the Sheriffs Office serves the largest population, serves as the Coroner, and provides technical fingerprinting expertise to local law enforcement agencies, the RAN Committee voted unanimously to use anticipated funds from Senate Bill 720 to purchase of a LEXS21 electronic work station by NEC Technologies, Inc., for an approximate cost of \$84,000 and a Nefax 791 facsimile machine, from NEC America, Inc., for an approximate cost of \$4,400 (including tax). (Attachments G & H; see letter from RAN Chair Tracy, Attachment I, and Meeting Minutes, Attachment J.)

#### Unanticipated Revenue from the DMV:

As per the DMV letter dated November 10, 1998 (Attachment K) Assembly Bill 1656, 1998-I 999 Budget Act, item 2740-I 01-0042, contains a \$25,000,000 appropriation from the State Highway Account. This money is appropriated to the California DMV for disbursement to counties by the State Controller in the form of interest-free funds, which Santa Cruz County can receive under Vehicle Code Section 9250.19(b) Fingerprint Identification. The Sheriff has applied for \$88,400 of the anticipated \$191,116 RAN

Committee funds, for 1999, to be paid in advance, in the form of an interest-free loan from the DMV, for the purchase of a latent fingerprint electronic work station and high-definition facsimile equipment for the Crime Scene Investigations unit of the Sheriffs Office.

As stated above, the DMV loan will be interest free and will be repaid by each county, in accordance with a repayment schedule established by the Department of Finance. The loans will be repaid within five years from the date that the actual collection of the fee commences by withholding 1/20th of the loan amount from each quarterly DMV vehicle licensing fee payment.

Therefore, I recommend your Board:

- 1. Authorize the Sheriff to execute an interest-free loan agreement for Vehicle Code Section 9250.19 funds with the State Department of Motor Vehicles, to be repaid with county vehicle license fees collected and distributed by the DMV and authorized under Board Resolution 435-97.
- 2. Adopt a resolution to accept and appropriate unanticipated revenue from Vehicle Code 9250.19 funds from the DMV in the amount of \$88,400, to implement the technological upgrade of fingerprinting equipment as recommended by the county's Remote Access Network (RAN) Committee.
- 3. Authorize the Sheriff to purchase a latent fingerprint electronic work station by NEC Technologies, Inc. and high definition facsimile system by NEC America, Inc., as a fixed asset (fixed asset specification attached), in an amount not to exceed \$88,400, to replace existing Year 2000 non-complaint equipment, as recommended by the RAN Committee and the Sheriff-Coroner.

On the motion of Supervisor Beautz Duly seconded by Supervisor Belgard The following resolution is adopted

RESOLUTION AUTHORIZING AN ADDITIONAL VEHICLE LICENSE FEE TO FUND THE ACQUISITION, INSTALLATION AND MAINTENANCE OF AUTOMATED FINGERPRINT IDENTIFICATION EQUIPMENT

WHEREAS, SB 720, enacted in 1997, adds Vehicle Code Section 9250.19 which authorizes boards of supervisors to impose, upon adoption of a resolution, an additional fee of \$1.00 paid at the time of registration, renewal or supplemental application for apportioned registration, of every vehicle registered to an address in Santa Cruz County, which additional fee is to be used to fund programs that enhance the capacity of local law enforcement to provide mobile and fixed location automated fingerprint identification of individuals who may be involved in driving under the influence of alcohol or drugs in violation of Section 23152 or 23153, or vehicular manslaughter in violation of Section 191.5 of the Penal Code, or any combination of those and other vehiclerelated crimes, and other crimes committed while operating a motor vehicle; and,

WHEREAS, funds collected pursuant to S.B. 720, upon recommendation of the RAN to the Board of Supervisors, shall be used exclusively for the purchase, by competitive bidding procedures, and the operation of equipment which is compatible with the Department of Justice's Cal-ID master plan, and the equipment

shall interface in a manner that is in compliance with the requirement described in the Criminal Justice Information Services, Electronic Fingerprint Transmission Specification, prepared by the Federal Bureau of Investigation, dated August 24, 1995; and,

WHEREAS, there exists in Santa Cruz County a local Remote Access Network (RAN) board created under the authority of Penal Code section 1112.4, which RAN board determines the placement of RAN equipment within the County and coordinates acceptance, delivery and installation RAN equipment.

WHEREAS, the additional vehicle license fee is needed for and shall be used for the purpose of funding the acquisition, installation and maintenance of automated fingerprint identification equipment, and the training of law enforcement staff in the operation of that equipment.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Santa Cruz County, that on and after January 1, 1998, an additional fee of \$1.00 shall be paid at the time of registration, renewal or supplemental application for apportioned registration of every vehicle registered to an address within Santa Cruz County as authorized by Vehicle Code section 9250.19.

BE IT FURTHER RESOLVED by the Board of Supervisors of Santa Cruz County, that the additional vehicle license fee shall be used by the Board of Supervisors, upon the recommendation of the Remote Access Network local board, to fund programs that enhance the capacity of local law enforcement to provide automated mobile and fixed location fingerprint identification of individuals who may be

involved in driving under the influence of alcohol or drugs in violation of Section 23152 or 23153, or vehicular manslaughter in violation of Section 191.5 of the Penal Code, or any combination of those and other vehicle-related crimes, and other crimes committed while operating a motor vehicle.

BE IT FURTHER RESOLVED by the Board of Supervisors of Santa Cruz County, that the Board finds that there is a substantial need for mobile and fixed location fingerprint identification equipment, which is compatible with the FBI and Department of Justice fingerprint data bases, by the law enforcement agencies within Santa Cruz County.

BE IT FURTHER RESOLVED by the Board of Supervisors of Santa Cruz County, that the fee authorized by Vehicle Code section 9250.19 shall no longer be imposed as of January 1, 2003, unless extended by legislation adopted hereafter but prior to that date.



MODERNIZATION OF FINGERPRINT INVESTIGATION EQUIP&NT

Dear Board Members:

On November 11, 1985, your Board approved the forming of a local committee to coordinate the implementation of the California Identification System (Cal-ID), also known as the Remote Access Network (RAN). The RAN Committee successfully implemented the Cal-ID system. Since that period the RAN Committee has been inactive. We would like to reestablish the RAN Committee.

### BACKGROUND ,

In, 1985, the California Department of Justice (DOJ) developed an automated fingerprint identification system (Cal-ID) with a remote access 'network so that law enforcement agencies all over the state could connect to the statewide fingerprint image file. A master plan was developed by DOJ that recommended the type, number and location of equipment necessary to implement RAN. This direct access has accelerated subject identification and works in conjunction with Live Scan Fingerprint System.

Senate Bill 1148, enacted in September of 1987, authorized the establishment of a County Automated Fingerprint Identification Fund. This allowed for the imposition of an assessment for every fine, penalty, or forfeiture imposed and collected by the Courts for criminal offenses, including all offenses involving a violation of the vehicle code or any local ordinance adopted pursuant to the vehicle code, except offenses relating to parking or registration. These funds are restricted to the purchase, lease, operation, including personnel and related costs, and maintenance of automated fingerprint equipment and the replacement of existing automated fingerprint equipment.

On January 1, 1998, Senate Bill 720 will go into effect (see Attachment 1). Senate Bill 720 authorizes the Department of Motor Vehicles to collect an additional \$1.00 fee to be paid at the time of vehicle registration, renewal, or supplemental application for apportioned registration pursuant to Article 4. Counties deposit these **funds** in their Automated Fingerprint Identification Fund. These funds can only be used for the purchase of equipment that is compatible with the Department of Justice Cal-ID master plan.

#### REESTABLISHING THE RAN COMMITTEE

In order for the Sheriffs **Office** to **qualify** for the **funds** stated above, a RAN Committee must be in place. The local committee meets annually and is responsible for deciding the location of the equipment within the County based on criteria specified in the Penal Code, and coordinates with the DOJ on installation and implementation of new systems. The DOJ requires the County **Beard** of Supervisors select one of it's members as a representative to be a part of this local committee. We will return with a complete list of committee members on December 16, 1997, however, the categories of membership are provided in **Penal** Code Section 11112.4(b) of Attachment 2.

#### RESOLUTION

It is necessary for your Board to adopt a resolution that authorizes collection of DMV registration fees (\$1) as assessed by SB 720. These funds will be deposited into the County Automated Fingerprint Identification Fund and will be used in compliance with the DOJ master plan.

### **JUSTIFICATION**

Modem technology now allows law enforcement officers to roll fingerprints over **computer**-supported equipment to scan and retain minute fingerprint detail for identification purposes. This process is termed the Live Scan Fingerprint System. This system is designed to enhance the **Cal-ID** system that we are currently using.

In order for Law Enforcement agencies to search the FBI automated fingerprint identification system, they must be scanning at 500 dots per inch. We are currently scanning at 300 dots per inch.

We currently print a card for each inmate booked into the Santa Cruz County Jail for our investigation purposes. This has generated **over** 180,000 fingerprint cards which has created a major storage problem. Our current live scan system was purchased in 1992 and is outdated.

Through adoption of the attached resolution, we will have the ability to purchase new electronic systems from the County Automated Fingerprint Identification fund. These new systems would

allow for a paperless retrieval of fingerprints, and the ability to search the FBI electronically (AFIS system) and State of California data banks for fingerprint verification.

### SUMMARY AND RECOMMENDATIONS

We believe that the recommended RAN Committee will enhance all local police agencies as well as Sheriffs Office. The purchase of new electronic equipment will allow us to be more efficient with staff time and have a better system for verifying inmates in our custody.

It is therefore Recommended that your Board:

- 1. Adopt the attached resolution authorizing an additional fee of \$1 .OO to be paid at the time of registration, renewal or supplemental application of apportioned registration of every vehicle registered to an address within Santa Cruz County;
- 2. Request the Chair to solicit Board Member interest in the RAN Committee with a final selection-to be made by the Board as a part of the December 16 report back on this matter;
- 3. Request the Auditor Controller's Office to open an interest bearing Automated Fingerprint Identification Trust Fund; and
- 4. Report back on December 16, 1997 with the complete list of RAN Committee Board members.

### **INTRODUCED BY Senator Lockyer**

### FEBRUARY 25, 1997

An act to add and repeal Section 9250.19 of the Vehicle Code, relating to vehicles, and making an appropriation therefor.

### LEGISLATIVE COUNSEL'S DIGEST

SB 720, Lockyer. Vehicles: registration fee: fingerprint identification.

(1) Existing law **imposes** fees upon the registration and renewal of registration of vehicles.

This bill would, in addition to the other fees imposed for the registration of a vehicle, impose, upon the adoption of a specified resolution by a county board of supervisors, with certain exceptions, an additional fee of \$1, and continuously appropriates the money to fund local **programs** that enhance local law enforcement to provide fingerprint identification. The bill would require that data from these programs be made available to local public agencies for purposes of criminal history backgrounds involving employment. To the extent that the bill would impose this requirement on local law enforcement agencies, the bill would create a state-mandated local program. These provisions are to be repealed as of January 1, 2003.

(2) The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for specified reasons,

Appropriation: yes.

SECTION 1. Section 9250.19 is added to the Vehicle Code, to read:

- 9250.19. (a) (1) In addition to any other fees specified in this code and the Revenue and Taxation Code, upon the adoption of a resolution pursuant to this subdivision by any county board of supervisors, a fee of one dollar (\$1) shall be paid at the time of registration, renewal, or supplemental application for apportioned registration pursuant to Article 4 (commencing with Section 8050) of Chapter 4 of every. vehicle registered to an address within that county except those expressly exempted from payment of registration fees. The fees, after deduction of the administrative costs incurred by the department in carrying out this section, shall be paid quarterly to the Controller.
- (2) A resolution adopted pursuant to paragraph (1) shall include findings as to the purpose of, and the need for, imposing the additional registration fee, and shall identify the date after which the fee shall no longer be imposed.

(b) Notwithstanding Section 13340 of the Government Code, the money paid to the Controller pursuant to subdivision (a) is continuously appropriated, without regard to fiscal years, for disbursement by the Controller to each county that has adopted a resolution pursuant to subdivision (a), based upon the number of vehicles registered, or whose registration is renewed, to an address within that county, or supplemental application for apportioned registration, and, upon appropriation by the Legislature, for the administrative costs of the Controller incurred under this section.

- (c) Money allocated to a county pursuant to subdivision (b) shall be expended exclusively to fund programs that enhance the capacity of local law enforcement to provide automated mobile and fixed location fingerprint identification of individuals who may be involved in driving under the influence of alcohol or drugs in violation of Section 23 152 or 23 153, or vehicular manslaughter in violation of Section 191.5 of the Penal Code or subdivision (c) of Section 192 of the Penal Code, or any combination of those and other vehicle-related crimes, and other crimes committed while operating a motor vehicle.
- (d) The data from any program funded pursuant to subdivision (c) shall be made available by the local law enforcement agency to any local public agency that is required by law to obtain a criminal history background of persons as a condition of employment with that local public agency. A local law enforcement agency that provides the data may charge a fee to cover its actual costs in providing that data.
- (e) (1) No money collected pursuant to this section shall be used to offset a reduction in any other source of funds for the purposes authorized under this section.
- (2) Funds collected pursuant to this section. upon recommendation of local or regional Remote Access Network Boards to the Board of Supervisors, shall be used exclusively for the purchase, by competitive bidding procedures, and the operation of equipment which is compatible with the Department of Justice's Cal-ID master plan, as described in Section 11112.2 of the Penal Code, and the equipment shall interface in a manner that is in compliance with the requirement described in the Criminal Justice Information Services, Electronic Fingerprint Transmission Specification, prepared by the Federal Bureau of Investigation and dated August 24, 1995.
- (f) This section shall remain in effect only until January 1, 2003, and as of that date is repealed, unless a later enacted statute, that is enacted on or before January 1, 2003, deletes or extends that date.
- SEC. 2. No reimbursement is required by this act pursuant to Section 6 of Article XIII B of the California Constitution because this act provides for offsetting savings to local agencies or school districts that result in no net costs to the local agencies or school districts within the meaning of Section 17556 of the Government Code.

Furthermore, no reimbursement is required by this act pursuant to Section 6 of Article XIII B of the California Constitution because the only costs that may be incurred by a local agency or school district are the result of a program for which legislative authority was requested by that local agency or school district, within the meaning of Section 17556 of the Government Code and Section 6 of Article XIII B of the California Constitution.

Notwithstanding Section 17580 of the Government Code, unless otherwise specified, the provisions of this act shall become operative on the same date that the act takes effect pursuant to the California Constitution.

ARTICLE 3.5. FINGERPRINTS AND PHOTOGRAPHS

Section 11 11 2.4. Local Boards; placement of RAN equipment

Subdivision (b). Except as provided in subdivision (c), each RAN board shall be composed of seven members, as follows: a member of the board of supervisors, the sheriff, the district attorney, the chief of police of the department having the largest number of sworn personnel within the county, a mayor elected by the city selection committee established pursuant to Section 50270 of the Government Code, and a member-at-large chosen by the other members. In any county lacking two chiefs of police, a substitute member shall be selected by the other members on the board. Groups of counties forming a region shall establish a seven-member board with each county having equal representation on the board and at least one member-at-large. If the number of participating counties precludes equal representation on a seven-member board, the size of the board shall be expanded so that each county has at least two representatives and there is a single member-at-large.

# Santa Cruz County Remote Access Network (RAN) Committee Needs Assessment

### I. Introduction

**The RAN Committee:** The Remote Access Network (RAN) Committee is a uniform statewide network of equipment and procedures that allow local law enforcement agencies direct access to the California Identification System (CAL-ID). The CAL-ID is an automated system maintained by the Department of Justice for retaining fingerprint files and identifying latent fingerprints.

The Santa Cruz County RAN Committee was reformed in 1998, and is responsible for making recommendations to the Board of Supervisors regarding the purchase of equipment compatible with the Department of Justice CAL-ID master plan, using Senate Bill 720 funds. Membership categories for the RAN Committee are established by the State Penal Code and include a Member of the Board of Supervisors, the Sheriff, the District Attorney, the Chief of Police of the department having the largest number of sworn personnel within the county, a second Chief of Police, selected by all other Chiefs within the county, a Mayor selected by the City Selection Committee; and a Member-at-Large chosen by other members of the RAN Committee.

**The Assessment:** The RAN Committee met on October 29, 1998 and determined that a county-wide assessment of current and projected applicant and criminal fingerprinting needs would be helpful in determining the short and long-term plans for usage of the \$200,000 per year, for five years, fi-om 1999 through 2004, expected funding from Senate Bill 720.

Interviews were conducted with the Chiefs of Police from Capitola, Santa Cruz, Scotts Valley, University of California at Sant Cruz (UCSC), Watsonville and the Sheriff. A visit was made to the crime scene lab at Monterey County Sheriffs Office, and numerous telephone interviews were conducted with the DOJ and various sheriffs offices and police departments throughout California, from November, 1998 through January, 1999.

Following is a report on current and projected county-wide fingerprinting usage by agency, a report on equipment expenses to date with projected future warranty costs, and preliminary recommendation for a five-year plan, including the immediate purchase of a LEXS2 1 Electronic Work Station to replace our existing CAL-ID Electronic Verification Only Terminal (EVOT), which is not Year 2000 compliant.

# - II. Summary

To date, funds allocated for use on fingerprinting technology for Santa Cruz County are limited to one million dollars over a five-year period. Until such a time that additional funds have been identified, trust fund money should be used efficiently to ensure getting the most long-term "bang for our buck," while providing key services to the community by:

- Complying with legislation regarding sex, arson and drug registrants;
- Providing fingerprinting service to educators and general public or applicants;
- Maintaining state-of-the-art fingerprinting technology for the identification and apprehension of **criminals.**

Therefore, a brief summary of advisable plans for usage of RAN trust funds are as follows:

- General: In accordance with DOJ's written Terms and Conditions for Operating Applicant Live Scan Devices: "Maintenance costs for live scan devices will be paid by the agency receiving the equipment." Additionally, all agencies will go direct connect until such a time that real benefits can be realized by going through the Sheriffs Store & Forward, and staffing resources become available.
- **Registrant:** By Year 3, print sex and arson offenders from one central location operated by the Sheriff's Office on Water Street in Santa Cruz. (Drug offender prints do not need to be sent to DOJ.)
- 3) Applicant: Provide mid-county applicant service and continue to seek funding for additional devices. Police departments receiving Live Scan devices will provide applicant fingerprinting services, as well as criminal (registrants).
- 4) Criminal: 1 O-Print: Our county's immediate booking needs will be met by Juvenile Hall and Main Jail booking. No additional devices should be purchased with RAN funds until all possible grants from DOJ are exhausted, and such a time that our current devices have been operational for at least one year.
- Criminal: Least cutte county's only device for unidentified fingerprinting is not Year 2000 compliant, RAN funds in the amount of \$84,000 should be used to pay for NEC's CAL-ID EVOT replacement, a LEXS21 electronic work station. The purchase process would be initiated Year 1, by the Sheriffs Office; all county law enforcement agencies would have access to and benefit by this purchase.
- 6) Criminal: Data Base: As law enforcement agencies agree to the importance of creating and accessing a local data base of fingerprints and photo images which interfaces with county-wide criminal records, the bulk of the RAN funds should be allocated to building the infrastructure and creating a system needed to share this information, starting Year 3.

7) Contingency: A sum of money (\$60,000) will be set aside for Year 2 to pay for the purchase of a Live Scan device or other equipment, as determined by the RAN Committee, after all DOJ grant options have been explored, and needs have been clearly defined. This amount assumes at least one device will be awarded to the county by DOJ. If this is not the case, the contingency amount increases to \$100,000 to cover the costs of two devices. At this point, optimistic expectations are for at least one device.

The DOJ expects to stop accepting fingerprint cards December, 1999. Assuming no additional devices are added to Santa Cruz County, the following scenario exists for Registrant, Applicant and Criminal use, for Year 1: January through December, 1999.

## III. Registrants:

Year One /1999

**Programming Live Scan for Registrants:** The DOJ has not developed programming to replace registrant information cards. Once this is developed, all criminal Live Scan devices will need to receive additional software and be **programmed to** produce registrant screens. A target date for this is note even set, yet. Therefore, offender registration will continue to be ink roll until such a time that DOJ and our devices have been reprogrammed, which will probably not be in Year 1. Additionally, it is recommended that all agencies review the July 19, 1996 VCIN Manual (and February 18, 1997 Supplemental) to ensure that we are printing efficiently. (see Registrants Year Three/2001)

# IV. Applicants:

Year One/1999

Currently there are two locations mid-county for applicant fingerprinting: County Office of Education (COE), in Capitola, and Sheriffs Office at Cabrillo College, in Aptos. These two devices were provided by DOJ and earmarked for education. COE originally agreed to only do school districts (estimated 2600 annually), and Cabrillo College agreed to print their own educational applicants and the general public (estimated 800 annually).

COE: Active since October, 1998, COE has agreed to provide service for general public every day, from 12:30 to 4:30 p.m. They charge a \$13 fee for educators and \$15 for all other applicants. They estimate that the combined time for rolling (9-10 minutes) and administration is 20 minutes per applicant, and have offered to increase their hours to accommodate more applicants, if needed.

**Cabrillo:** Live since the end of January, 1999, Cabrillo charges \$15 per registrant, and offers fingerprinting services to the public from 2:30 to 5:30 p.m., Monday through Thursday. They, too, will increase hours if needed.

An estimated 65% of applicants live within a 10-mile round trip of these two agencies, which are accessible by public transportation. The remainder will be expected to travel a maximum of 30 to 40 miles, round trip, for a service which they require infrequently at best. This is not considered a hardship when compared to Monterey County, where applicants may need to travel 50 miles to the nearest device. With regards to Parks and Recreation, sports teams, and groups, careful planning and coordination with Cabrillo College and the COE could make weekend registration possible for Year 1, or until outside funds have been identified which will allow for the purchase of additional devices.

**DOJ Applications:** The Sheriffs Office is tenaciously submitting on-going requests to the DOJ CAL-ID / Live Scan Program in Sacramento, for additional Live **Scan** devices for Santa Cruz County. Most recent (February, 1999) plans include a device for Watsonville Police Department and for the Sheriffs Office at Government Center, in that priority order. Every known effort is being made to obtain these additional devices **from** DOJ.

## V. Criminal:

Year One/1999

**TENPRINTS:** "Have the person" Under the system established by the State, the Main Jail will electronically scan and capture live fingerprints of offenders and re-offenders during the booking process, using an electronic system called Live Scan. These images are transmitted to the California Identification System (CAL-ID) network, comprised of the Master Name Index (MNI), Automated Fingerprint Identification System (AFIS) Automated Latent Print System (ALPS), the Digital Image Retrieval System (DIRS) and the Remote Access Network (RAN). This is done for three reasons: "Identified": 1) To verify that the re-offender's fingerprints match the name he or she has provided, assuming that the fingerprint is in the databases; 2) To add the name, demographics and prints of the new offender to the state-wide data base; and "Unidentified": 3) To identify the body you have, when you do not know who it is.

Formerly located in the Main Jail, an old CAL-ID <u>Enhanced Verification Only Terminal</u> (EVOT) was an affordable way of searching state databases, and served two primary functions: name and print matching for booking and latent print searching for criminal investigations. The new Identix 600 Live Scan device in Main Jail booking will replace the function of matching the name to the correct fingerprint, however the criminal investigations function of latent print identification will no longer be possible after December, 1999. (More *on this under Latents*.)

• MAIN JAIL: The Main Jail expects to go live March/April, 1999, using Identix 600 Live Scan devices for Booking and Work Release. They expect to book 15,000 offenders from agencies county-wide in 1999. Work Release will handle approximately 5,000 citations and release arrestees by direction of the court. Work Release will also fingerprint job applicants for the Sheriffs Office, which has obtained applicant agency status for this purpose.

- CSI: STORE & FORWARD: The Crime Scene Investigation (CSI) unit of the Sheriffs Office purchased an Identix Store & Forward system to eliminate the physical transport of fingerprinting records from the Main Jail to CSI. The Store & Forward will be used when investigators want to make printed copies and to review and/or update records with post-booking information. Agencies with criminal Live Scan devices and printers would not necessarily need to go through this Store & Forward. Until such a time that the benefits of having multiple agencies go through the Store & Forward are known and staffing is available, criminal and applicant devices will connect directly with DOJ. Only the Main Jail Booking and Work Release will go through the Sheriffs Store & Forward.
- **JUVENILE HALL:** Probation Department expects Juvenile Hall to go live in **February**, 1999. They will book a total of 1600 offenders in 1999. They are in the process of applying with DOJ for applicant agency status, for fingerprinting Probation Department job applicants (approximately 200 per year). As it is a locked, secure facility, Juvenile Hall can not currently accommodate other applicant fingerprinting use.

Local law enforcement agencies will be able to print non-bookable juveniles at the Hall, provided the temporary hold on juveniles is "reasonable." There are some new guide lines out regarding non-detention status of juveniles, and this issue requires further research. Procedures/protocols will be considered once the device is in operation.

No additional devices should be purchased with RAN funds until all possible grants from DOJ are exhausted, and such a time that our current devices have been operational for at least one year allowing for evaluation of devices and policies.

**LATENT PRINTS:** "Don't have the person": The Sheriffs Office, as the county's only Electronic Verification Only Terminal (EVOT), along with other law enforcement agencies, can introduce an unidentified fingerprint into the old CAL-ID EVOT terminal, and search the ALPS database, with no other identification whatsoever. This device provides a list of candidates with State Identification Numbers (SIN) for the person who's fingerprints were submitted, if the fingerprints provided possibly match records maintained in the **DOJ's** database.

This old EVOT, the county's only device for use with unidentified fingerprinting, was purchased over 10 years ago, is not Year 2000 compliant, and will no longer be accepted by the State, effective December, 1999. To replace the lost functionality, the DOJ recommends a new LEXS21 Electronic Work Station by NEC Technologies, Inc. This workstation would be a replacement to first (and second, which we did not buy) generation CAL-ID EVOT equipment, for implementing AFIS2 1 (AFIS for the 2 1 st Century) software. It would be our county's only available means of connecting to the DOJ for this purpose.

Additionally, the DOJ has announced that Tenprint functionality will no longer be a feature offered to it's-remotes. This means that when the Sheriffs Crime Scene Investigators (CSI) must identify individuals for court or other reasons (approx. 50 per year), they will have to use a

Live Scan device, as the new work station will only do latent prints. There is not currently a Live Scan device in CSI on the third floor of the Government Building office, however requrests are being made to DOJ.

As the Main Jail will be able to do electronic identification verification on their Live Scan device for Booking purposes, the current CAL-ID EVOT device will move to CSI for the months prior to December, 1999, when it becomes defunct. As the Sheriff's Office serves the largest population, serves as the Coroner, and provides expert fingerprinting technician services to local law enforcement agencies, RAN funds should replace this latent fingerprint device, which would be located in the Sheriffs Office. All county law enforcement agencies would have access to and benefit by this purchase.

RAN Trust should fund the estimated cost of \$84,000 for the purchase of a LEXS21 work station to provide county-wide latent fingerprint identification. As with the older CAL-ID EVOT device, the Sheriffs Office would pay all maintenance costs for this device, estimated at \$6,300 per year. RAN Committee Members will vote on this Action Item at the February 5, 1999 RAN Committee Meeting to expedite the lengthy purchase process and allow adequate time for installation and training before December, 1999.

### VI. Year Two / 2000

**Contingency Amount:** Year 1, 1999, will have installations, training and grant applications. Additionally, several law enforcement agencies are planning transitions, Records Management System upgrades, and Year 2000 upgrades. By Year 2, the RAN Committee will have more information, experience, and — hopefully — more electronic fingerprinting devices than at the present time. Evaluating input from law enforcement agencies, Cabrillo College, the COE and the community will define where, if any, an additional device should go. Setting aside \$60,000 as a contingency will allow for flexible problem solving to the concerns we cannot foresee at this time. For example, if Watsonville Police Department does not receive a device and printer from the DOJ by Year 2, one could be paid for with this contingency amount. If they have received a device, and the Sheriff's Office has not, then this money could be used to secure a device for the Government Center location, to service North County, Santa Cruz City, UCSC and others. If both Watsonville Police Department and the Sheriffs Office already have devices by Year 2, this fund could be used for full or partial payment of other equipment, a card scanner or additional Live Scan device as identified by the RAN Committee. If neither Watsonville Police Department nor the Sheriffs Office receive a Live Scan device from the DOJ, then the Contingency Amount would need to be increased to approx. \$100,000 for the purchase of this equipment.

**Data Base Task Force:** The balance of the expected \$200,000 would be saved and put towards developing a county-wide database for fingerprint, photo imaging and detention records in Years 3, 4 and 5. A Task Force would be established to research how other counties are sharing their information, what new technologies have been developed, what the options and expenses are, what benefits there are to connecting with a central Store & Forward, and report back to the RAN Committee.

**Registrants:** The Sheriffs **Office** will move forward with its plans to develop a central location for offender registration.

# VII. Year Three / 2001

Registrants: Convicted sex, arson and drug offenders are required by law to register with the Chief of Police of the city in which he or she resides, or with the Sheriff if residing in unincorporated area (or has no residence), and with the Chief of Police of the campus of the University of California where the person is domiciled, within 30 days of relocating to that area. However, per DOJ's Sex and Arson Registration Program Asst. Manager Mary Langley (9 16)227-3 520, transfer of "ownership" of these registrants is either very simple or not necessary so long as we continue our input into the Violent Crime Information Network (VCIN) via the California Law Enforcement Telecommunications System (CLETS). The location where offenders register remains the decision of the Sheriff and Chiefs.

- Central Sheriff's Office Location as of 2001: Currently being printed by all agencies county-wide, the Sheriffs Office could register offenders at a central location (in front of the main jail on Water Street, in Santa Cruz), once the facility has been renovated. Plans are currently underway, and expected completion date is the year 2002. Should there be an interim period (Year 2), between when the DOJ mandates offenders register electronically, the Sheriffs Office would hope to process registrants at its Government Center location, if awarded a Live Scan device for this purpose. If not, the Sheriff's Office will arrange to process registrants at its Work Release location at the Main Jail. Any related costs for this service would need to be discussed and approved prior to implementation. As registrants of unincorporated areas already travel from as far as Watsonville and Bonny Doon to the Ocean Street Sheriffs Office, no change in registration rate is expected by the formation of this central location.
- **DOJ does not process Narcotics Offenders:** As the DOJ stopped providing narcotic offender record services effective September 1, 1991, and are merely archiving any fingerprint cards they receive, law enforcement agencies will not have to electronically print narcotic registrants. They may choose to continue to print (ink roll) these registrants for their own use, and even to forward to the DOJ for archiving, as they determine what course of action is best for their own agencies.
- Sex and Arson Offenders: Agencies are only required to fingerprint Sex and Arson registrants who have never registered in the State of California. This is verified via the VCIN data base, accessible via CLETS. Therefore, annual registrations or changes of address (an estimated 90%) do not reauire a full set of mints, but merely the thumb print on the yellow Registration Program form, "Registration Change of Address / Annual Update." These forms are input by the Sheriffs Records Department and filed and do not go to the DOJ. (Presently, county-wide sex and drug registrant information is entered into the Sheriffs local records database, as well.)

Therefore, only an estimated 10% of each agency's total sex and arson registrants will need to be Live Scan printed and forwarded to DOJ. These new registrants could be done at one location.

**Shared Database:** By Year 3 the Database Task Force will know if a consultant and needs assessment is required, or if enough expertise and information is available to proceed with the development of a shared database. By Year 3, law enforcement agencies may have new RMS in place and have a clearer idea of their interface needs. A small portion of Year 3 funds (25% or up to \$50,000) could be used to hire a consultant to prepare a needs assessment and recommend a system (infrastructure, interfaces, software, hardware, etc.) which would achieve our goal of sharing criminal information. The remainder of funds would be saved and put towards development of this new system.

# VIII. Year Four & Five / 2002 & 2003:

All funds from Years 4 & 5 will be used for development and implementation of the shared data base, with a target completion date of December, 2003.

### IX. GENERAL:

- Until such a time that Santa Cruz County can reclaim additional RAN funds or identify new ones, SB720 funds will be used primarily to build infrastructure for sharing of criminal fingerprints, photo images and criminal records among all law enforcement agencies. Annual RAN Trust Funds will be saved for big-picture, long-term goals. RAN funds should not be used for short-term, minor expenses.
- Warranty, maintenance and installation costs must be paid by the agency receiving the equipment, according to the **DOJ's** Terms and Conditions, item 4. According to DOJ Field Rep. Thorn **Louie**, we are obligated to follow through with these "rigid" terms and conditions, and deviations may be made by CAL-ID management staff (Norm Pierce and/or Gary Cooper).
- Agencies who purchase Live Scan devices with their own funds are asked to keep the RAN Committee informed, to maintain a well-coordinated county-wide effort.
- The Sheriff intends to continue to make administrative support available to provide county-wide Live Scan coordination to the RAN Committee and local law enforcement agencies.

# X. Input From the Chiefs & Sheriff November, 1998

- Strong willingness for inter-agency cooperation and planning by all Chiefs & Sheriff
- Same long-term goal of sharing information (prints, images, DMS & RMS)
- Recognition that county-wide cooperation among agencies is at a high point
- Shared optimism in potential to share information in future, especially given current RMS plans with several agencies, and technological trend to move from mainframe to PC network environment.
- General support of technology and proposed changes mandated by DOJ
- Strong emphasis on importance applicant usage, public perception, inconvenience to public
- Supportive of central location for registrants, keeping in mind legal obligations and risks; mixed ideas about agencies paying fees to register their offenders.
- Consideration of Parks & Recreation needs (perhaps a dedicated device for them?) and local volunteer work schedules
- Suggestion to consider paying warranty fees on criminal use devices only
- Suggestion that each agency pay for own warranty, regardless of usage
- Discussion about printing but not booking juveniles; reasonable hold on juveniles
- Discussion about local agencies using new Juvenile Hall
- Concern for availability of Live Scan for law enforcement agency usage
- (weekends, etc.)
- Idea of making applicant devices pay for themselves through applicant fees
- Support of using print card scanner in "remote" locations
- Suggestion that a percentage of applicant fee be returned to the RAN Trust fund as a pool for future use
- "Fear of losing track of sexual predators" may be a useful line with funding sources
- Recognized need to research applicant fee, and potential to increase this fee to cover documented costs (including warranty)


## XII. NEXT STEPS:





The Remote Access Network (RAN) Committee met on February 5<sup>th</sup>, 1999. At this meeting, representatives of the Sheriffs Office Crime Scene Investigations (CSI) unit gave an informative presentation on the latent fingerprinting needs of Santa Cruz County. CSI drew attention to the fact that the only Electronic Verification Only Terminal in the county was not Year 2000 compliant, and was in need of replacement. CSI also explained that the addition of a high definition facsimile machine would improve response from the Department of Justice, from several weeks to a matter of hours. The Sheriffs Office requested RAN Committee funds be used to purchase this equipment.

As the Sheriffs Office serves the largest population, serves as the Coroner, and provides expert fingerprinting technician services to local law enforcement agencies, the RAN Committee voted unanimously to use anticipated funds from Senate Bill 720 to purchase of a LEXS2 1 electronic work station by NEC Technologies, Inc., for an approximate cost of \$84,000 (quote attached), and a Nefax 791 facsimile machine, from NEC America, Inc., for an approximate cost of \$4,300 (including tax, quote attached). Minutes and agenda of this meeting are attached.

As Chair of the RAN Committee, I am convinced that use of RAN funds to purchase this equipment will benefit all local law enforcement agencies, as well as the community we serve.

## REMOTE ACCESS NETWORK (RAN) COMMITTEE MEETING

### Minutes February 5, 1999

Committee Present: Sheriff Mark Tracy, Howard Skerry (for Chief Belcher), Supervisor Jeff Almquist, Denise Nickerson, April Bullock, Carol Girvetz, Ellen Metcalf, John Strimaitis, Craig Little, Mike Lillis, John Rhoads, Paul Marigonda (For Kate Canlis), and Lisa Mardesich

Sheriff Tracy called the meeting to order at 9:00 a.m.

Additions and Deletions to the Agenda: None

**Approval of Minutes:** Mark Tracy made a motion to approve the minutes. Howard Skerry 2<sup>nd</sup> the motion. All were in favor.

**Oral Communication:** None

### Update from Ran Committee Chair:

- A. Supervisor Jeff Almquist was welcomed as the newest member to the Ran Committee.
- B. Tracy stated that a letter has been written on behalf of the Ran Committee to the Mayor Select Committee, in c/o CAO Susan Mauriello requesting replacement of former Mayor Denis Osmer.
- C. Court House Construction Fund/Criminal Justice Facility Construction. Due to Chiefs Walpole and Belcher's absence, this will be discussed at a future meeting.

### **Update of Live Scan Implementation Schedule:**

Denise Nickerson gave a brief overview and update of Live Scan implementation.

- A. Cabrillo College's Live Scan system was installed January of this year. Personnel are trained and will fingerprint applicants from the Cabrillo College Community and the general public..
- B. Juvenile Hall has received their Live Scan System. Training for Juvenile Hall personnel is scheduled for mid February.
- C. Installation of the Sheriffs Office Main Jail and Work Release Program Live Scan System. Training has been delayed until March/April due to computer gateway (data field) problems between Detention Management System and Live Scan.

John Rhoads stated his department was contacted by DOJ and was told that because Probation has a Live Scan System, they will be required to fingerprint applicants. Nickerson has since researched this and found it to be erroneous.

### **Focus** on Criminal Fingerprinting:

Lt. Mike Lillis of the Sheriffs Office Investigations Unit introduced Sgt. Craig Little and Detective John Strimaitis, Crime Scene Investigators. They gave a presentation highlighting the history and progression of the EVOT (Electronic Verification Only Terminal) system. The Sheriffs Office is asking the RAN Committee to purchase the LEXS21. This will replace the current EVOT system which will be obsolete January 1, 2000. Sgt. Craig Little also asked the Ran Committee to consider the purchase of a 4 bit fax that would be linked to DOJ thus allowing the Sheriff's Office to obtain identification of fingerprints within a two minute time frame. The cost of the LEXS21 is approximately \$84,000 and the 4-bit Fax \$4,000. At the end of the presentation, the floor was opened to questions.

Carol Girvetz of the **CAO's** office asked if the Department of Justice charges for criminal fingerprinting. Sgt. Little stated there is no charge; however, the Sheriff stated that there are other indirect costs. Denise Nickerson stated that DOJ charges for regular applicants - approximately \$32-\$45.

### County Wide Assessment Outline - Results/Recommendations:

Denise Nickerson distributed reviewed copies of the RAN Committee Needs Assessment for Santa Cruz County. She said that we were, and have been, learning about our county's fingerprinting needs, and this report should serve as a working document to help us plan for the future. She made the following points:

- We should continue to obtain as many devices as possible from the Department of Justice.
- Booking will be done by the Main Jail (March/April '99) and Juvenile Hall (February '99).
- Two additional devices are being **requested of** the DOJ for Watsonville Police Department. and the Sheriffs Office at the Government Center. Applicants would be printed at these agencies, in addition to the County Office of Education (COE) and Sheriffs **Office at Cabrillo College**. The RAN Committee should purchase these devices for Year Two, if they are not awarded by the DOJ.
- Registrants would be printed in South County at Watsonville Police Department, and at the Sheriff's Office, which is currently making plans for a facility to do this.
- Programming to do registrants has not been developed as yet. Timing and potential costs are unknown. Nickerson will research the costs further.
- Nickerson recommended that the bulk of the budget be held in a reserve for Years Three, Four and Five to create an inter-agency system and sharing photo images, fingerprints and criminal records, which was the stated goal of all Chiefs during her interviews.

Chair Tracy reiterated that this plan is a working document and parts of it would be discussed by the RAN Committee at later dates.

### Nickerson invited questions:

April Bullock referred to the "draft" Needs Assessment Report, page three, "the DOJ has not developed programming to replace registrant information cards," and asked when DOJ determines the software needed, who will absorb the costs of the program and upgrades. Nickerson will research this.

Supervisor Almquist stated that he would like to see Juvenile Hall designated as a place for San Lorenzo Valley Community to have applicant fingerprinting done. Chief **Rhoads** stated there are concerns with where the machine will be placed and whether it would pose as a safety/health care issue. Rhoads did state, however, that the possibility of scheduled weekend applicant fingerprinting might be possible.

Supervisor Almquist asked if the machines will need to be calibrated as part of routine maintenance and what the \$6,800 covers in maintenance costs. He also suggested that there may be someone more local to provide these services. Nickerson answered that costs are determined by service, either 24-hours-day/7 days, or 40 hours per week and are set by the vendor and paid by the agency with the device. Strimaitis added that his experience is that the vendor knows the equipment better than a 3<sup>rd</sup> party.

CAO Girvetz asked if the new fingerprint policies; as they relate to juveniles, will have any effect on Juvenile Hall population. John Rhoads answered that it would not. Generally, juveniles would, in most cases, be fingerprinted and released on citations similar to what is being done in Watsonville at this time.

Nickerson agreed to follow up on three items:

- · Conduct a cost analysis for the Sheriffs Office printing approximately 3,000 applicants in Year 2000.
- Research if the DOJ or the Live Scan agency would be responsible for the programming costs associated with printing Registrants and future upgrades needed to work with DOJ.
- Scheduled Applicant fingerprinting on weekends at Juvenile Hall in the future.

Chair Tracy thanked Nickerson for her work on the analysis.

**Action Items:** Chair Tracy requested that the Committee address the action item of purchasing the LEXS21 Electronic Work Station at the cost of approximately \$84,000. Howard Skerry made a motion to accept and approve LEXS21 Electronic Work Station with the addition of an approximately \$4,000 4-bit Fax with RAN Committee Funds. Supervisor Almquist 2<sup>nd</sup> the motion. The Committee unanimously voted in favor of these two purchases.

The Next Meeting date will be set at the end of March or beginning of April. The meeting was adjourned at 10: 10 a.m.
