Resolution Accepting and Appropriating Unanticipated Revenue from State Office of Criminal Justice Planning for the Violence Against Women, Probation Specialized Unit Program

Dear Board Members:

On January 26, 1999, your Board approved the Probation Department's application to the Office of Criminal Justice Planning (OCJP) for the purpose of establishing a Violence Against Women, Probation Specialized Unit program. We are pleased to inform your Board that the grant application was approved and that the signed grant award has been received by the Probation Department. The grant award **from** OCJP is for a three-year period, beginning April 1, 1999 through March 30, 2002, and includes State funds in the amount of \$105,000 each year, totaling \$3 15,000. Required in-kind match in the amount of \$35,000 each year totals \$105,000, for a three-year budget total of \$420,000. It is now necessary to accept the unanticipated revenue and appropriate a portion of the funds and add two new positions to the Probation budget for the current fiscal year.

Salary costs for a Deputy Probation Officer II and Probation Aide, and related service and supply expenditures are fully funded by this grant award, and will be reimbursed though quarterly invoices to the Office of **Crimina**1 Justice Planning. There is no increase in net county cost as a result of the Probation Department's participation in this domestic violence program.

## IT IS THEREFORE RECOMMENDED that your Board:

- Adopt the attached resolution accepting unanticipated revenue in the amount of \$35,000 from the State Office of Criminal Justice Planning, and appropriate these funds for costs associated with the Probation Department's participation in the Violence Against Women, Probation Specialized Unit program, as described in the attached AUD-60; and
- 2) Add the following full-time, limited term (through March 31, 2002) positions to
