STATEMENT OF QUALIFICATIONS .

My interest in serving as a Commissioner on the County Commission for Disabilities, stems from my own disability. More than six years ago, I had a motorcycle accident which left me paralyzed from the chest down. Upon release from the hospital, I began searching out available resources.

One resource, Shared Adventures, local a non-profit organization which provides recreational activities to people with challenges, provided me with the most support. I have been an active volunteer since learning about the organization in 1993, can currently serve as a Board Member and provide secreterial support for our meetings.

Other resources I found were not so user-friendly, particularly, the health care system. I am interested in working with county agencies to affect positive changes in my community's health care system.

I understand the role of a Commissioner is to advise the Board of Supervisors on matters concerning the inequities in rights and opportunities for the disabled community. I can serve the Commission be taking an active role in working for the betterment of my community. I can provide a link between the Board of Supervisors, my neighbors and my friends who face challenges like myself.

I have always enjoyed community service and view this Commission vacancy as an opportunity for me to give back to the dynamic community in which I live and work.
