SUBJECT: BID AWARD - HARPER COURT PEDESTRIAN BRIDGE

Members of the Board:

The Board of Supervisors received eleven bids for the subject project on March 9, 1999, which have been checked by the Department of Public Works and found to be in order. The low bid was submitted by Anderson Pacific Engineering Construction in the amount of \$237,010.00. The engineer's estimate was \$268,935.00.

Sufficient funds are available for this work. The construction of this project is funded by Redevelopment funds. Redevelopment funds are being used because it has been determined that the improvements are of benefit to the project area or the immediate neighborhood in which the project is located, that no other reasonable means of financing the improvements are available to the community, that construction of the project will assist in the elimination of blight, and that the project is consistent with the Redevelopment Agency's five year implementation plan.


The Redevelopment Department has a letter to the Board of Directors of the Redevelopment Agency on today's agenda approving the expenditure of funds necessary for this contract.

It is recommended that the Board of Supervisors take the following action:

1. Make findings that the improvements are of benefit to the project area or the immediate neighborhood in which the project is located, that no other reasonable means of financing the improvements are available to the community, that construction of the project will assist in the elimination of blight, and that the project is consistent with the Redevelopment Agency's five year implementation plan.

2. Accept the low bid of Anderson Pacific Engineering Construction, in the amount of \$237,010.00, and authorize the award of the contract.
3. Authorize the Director of Public Works to sign the contract on behalf of the County of Santa Cruz.


