1985A CHANTICLEER AVENUE RENOVATION NOTICE OF COMPLETION - CONTRACT NO. CO81755

Dear Members of the Board:

In December, 1996, the Redevelopment Agency purchased the Chanticleer park site property; this property includes a number of residential units. At the time of the purchase, many of these units had been converted to illegal uses. Over the course of the last two years, ending with the 1985A Chanticleer Avenue renovation, we have remedied all of these illegal conversions.

The work to renovate and convert 1985A Chanticleer from an illegal duplex to a legal single family residence began on December 28, 1998 and was completed on March 4 of this year by the general contractor, Henry Van Siclen Construction. The original bid amount was \$28,605. An additional \$2,860 was allocated as a ten percent (10%) contingency, for a total of \$31,465. Various change orders were initiated during construction including rebuilding a rear porch landing, additional drywall repair, complete interior painting and exterior paint touch-up. These change orders amounted to \$2,860. The total construction was accomplished at a cost of \$31,465.

It is therefore RECOMMENDED that your Board, as the Board of Directors for the Redevelopment Agency,

- 1) Accept the project as complete;
- 2) Approve the final cost in the amount of \$31,465.00;
- 3) Authorize the Redevelopment Agency Administrator to execute the Notice of Completion, (Attachment No. 1); and
- 4) Direct the Clerk of the Board to file the executed Notice of Completion with the Office of the County Recorder.
