REQUEST TO IMPLEMENT CLASSIFICATION AND SALARY ACTION IN THE COURTS

Dear Members of the Board:

A classification and salary review has been completed regarding the Court Reporter classification in the Courts. The study recommends the application of an alternate salary range. Section 161 of the Salary, Compensation and Leave Provisions allows the use of alternate salary ranges to provide a means to compensate individuals who perform certain specified higher level technical or supervisory assignments within a class on a rotational basis. Attached Exhibit A identifies the specific criteria for assignment of the alternate salary range for the class of Court Reporter. Consistent with Section 161 it is recommended that the alternate salary range be aligned at 10% above the existing salary range for Court Reporter.

The affected department and employee organization are in agreement with the actions described above.

It is RECOMMENDED that your Board adopt the attached amendment to Resolution No. 279-75 to establish an alternate range for the class of Court Reporter, effective April 17, 1999.

Exhibit A

COURT REPORTER ALTERNATE RANGE CRITERIA

Alternate Range B

The hourly rate salary for each step in the alternate range B shall be 10% above the hourly rate for each step in the standard (base) salary range.

Alternate range B shall apply to an employee in a budgeted position in the class of Court Reporter when assigned responsibility to supervise a working unit of Court Reporters, provided that such application is consistent with the allocations designated by the Personnel Director.

The assignment shall include: Plan and assign the work of subordinate staff. Make decisions on difficult problems in connection with the work of subordinate staff. Schedule work to meet court deadlines. Establish priorities. Maintain liaison with other sections of the Court to insure efficient work flow. Assist subordinates in handling difficult or unusual problems. Review the work of subordinates for adherence to established procedure and conformance to applicable rules and regulations. Make recommendations on or select subordinate staff. Prepare performance evaluations. Issue warnings. Prescribe work schedules and vacation plans. Direct the training of subordinates. Instruct new employees in departmental policies and rules. Provide explanations to employees, departments and the public which require knowledge of Court operations and of departmental operations, rules and procedures.

A maximum of one employee may be placed at alternate range B for Court Reporter.
