## RESOLUTION AUTHORIZING THE COUNTY ELECTIONS OFFICIAL TO CONDUCT JUNE 8.1999 SPECIAL ELECTION

**WHEREAS**, the governing body of any city or district may be resolution request the board of supervisors of the county to permit the county elections official to render specified services to the city or district relating to the conduct of an election. Subject to approval of the board of supervisors, these services shall be performed by the county elections official (Elections Code §1 0002);

**WHEREAS**, services shall include all necessary duties prescribed by law to conduct the election (Elections Code §10002);

WHEREAS, unless other arrangements satisfactory to the county have been made, the city or district shall reimburse the county in full for the services performed upon presentation of a bill to the city or district (Elections Code \$10002);

**WHEREAS**, the City of Scotts Valley has requested that a special election be held on June 8, 1999 for the purpose of considering two referendum measures.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED,** that the Board of Supervisors of the County of Santa Cruz hereby permit the county elections official to render specified services to the city relating to the conduct of the June 8, 1999 election.

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SCOTTS VALLEY REQUESTING A SPECIAL ELECTION AND ORDERING OF SUCH ELECTION

WHEREAS, the City Council of the City of Scotts Valley orders that an election be held on Tuesday, June 8, 1999 for the purpose of:

a) Submitting two referendums to the voters:

'shall Ordinance No. 16-ZC-186 of the City of Scotts Valley approving the specific plan, rezoning, and the development agreement for the 'Glenwood Project' be adopted? YES OR NO"

"Shall Resolution No. I 119.16 of the City of Scotts Valley approving an amendment to the General Plan for the 'Glemvood Project' be adopted? YES OR NO"

WHEREAS, whenever two or more elections of any district, city, county, or other public subdivision are called to be held on the same day, in the same territory, or in territory that is in part the same, they may be consolidated upon the order of the governing body, or officer calling the elections (Elec Code  $\oint 10400$ ) and pursuant to the procedures for consolidation with a statewide election (Elec Code  $\oint 10402$ ); and

WHEREAS, pursuant to Elections Code Section 10400, whenever one of the elections to be consolidated is a statewide election, the district, city, county, or other political subdivision shall file with the Board of Supervisors and file a copy with the County Clerk, a resolution of its governing board requesting such consolidation and setting forth the exact form of any question, proposition or office to be voted upon at such election as the same is to appear on the ballot. Upon such request, the Board of Supervisors may order the consolidation; and

NOW, THEREFORE, BE IT RESOLVED AND ORDERED THAT THE City Council of the City of Scotts Valley hereby orders a special election to be called, and consolidated with any and all elections that may also be called, to be held on Tuesday, June 8, 1999, insofar as said elections are to be held in the same territory or in territory that is in part the same as the territory of the City of Scotts Valley request the Board of Supervisors of the County of Santa Cruz to order such a special election, or consolidation, under Elections Code 10400.
