SUBJECT: 1998 STATE TRANSPORTATION IMPROVEMENT PROGRAM (STIP) AUGMENTATION FUNDS, ADDITIONAL ROAD REHABILITATION PROJECT CANDIDATES

Members of the Board:

On February 23, 1999, as the County's initial proposal to the Santa Cruz County Regional Transportation Commission (SCCRTC) for 1998 State Transportation Improvement Program (STIP) Augmentation **funding**, your Board approved a revised route concept for the reconstruction of Graham Hill Road between Roaring Camp Road and the existing climbing lane. At that time, your Board also directed Public Works to return to your Board today with a list of additional regional road rehabilitation project proposals for application to the SCCRTC for additional 1998 STIP Augmentation funding.

A preliminary list of some \$14 million of road rehabilitation/resurfacing needs, compiled from the current Public Works Pavement Management Report (PMR), was submitted to the SCCRTC last November to **identify** the County's funding shortage in maintaining its main arterial routes (see attached table). This was in response to the SCCRTC's request for local transportation system needs to be considered in relation to the \$8,843,000 in 1998 STIP Augmentation revenue they expected to receive this year from the California Transportation Commission (CTC). The SCCRTC asked each transportation agency within our county to submit ready-to-build projects that fit one of two priorities: The State's first priority was to fund the local share costs of the storm damage road repair work still remaining from the 1996, 1997, and 1998

its June agenda.

The balance of the Augmentation funding, approximately \$5 million, would go to the second priority type of projects, which would include regionally significant road or transit rehabilitation projects that could be built within the next three years (based on the 1998 STIP funding cycle), and that can be shown to be cost effective and consistent with existing transportation plans (as mandated by TEA 21). Among these projects, special consideration would be given to previously approved SCCRTC projects which are currently under-funded (i.e. Graham Hill Road). In addition, due to the complexity of the state and federal processing procedures mandated by the CTC and the limited **funding** available, the SCCRTC is requiring that any project submitted be at least \$250,000 in cost, so as to eliminate any smaller projects that could be funded by other programs.

Based on the preliminary list of County road segments (see attached table) submitted to your Board and the SCCRTC last November, we would recommend that your Board consider the following regional arterial routes as additional project candidates for 1998 STIP Augmentation funding:

***PCI** = Pavement Condition Index (a rating of 25 to 100, indicating the condition of the road's existing structural section, with 100 representing a newly constructed roadway)

SCCRTC staff has requested that project applications be submitted to their office no later than April 17, 1999. Therefore, upon your Board's approval, Public Works will submit draft project study reports (PSR) and applications for these three additional proposals to the SCCRTC for **STIP** Augmentation funding consideration. It is therefore recommended that the Board of Supervisors take the following action:

- 1. Approve the additional **\$2,063,000** for road rehabilitation work on Empire Grade Road, Freedom Boulevard and Soquel-San Jose Road as the County's application to the Santa **Cruz** County Regional Transportation Commission (SCCRTC) for funding consideration from the 1998 State Transportation Improvement Program (STIP) Augmentation revenue.
- 2. Direct Public Works to return to the Board at the time of the Road Budget hearing with the results of the 1998 STIP Augmentation fund application process.
