Public Works is in receipt of checks in the amount of \$1,733.75 for reimbursement of utility trench repair work on View Point Road, County Service Area No. 25. The checks are from Pacific Gas and Electric in the amount of \$1,106.75 and Soquel Creek Water District in the amount of \$627.00 for a total of \$1,733.75.
