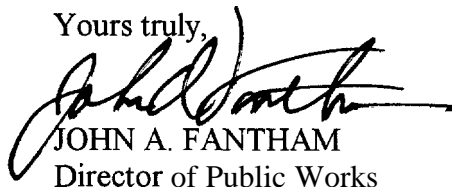
SUBJECT: UNANTICIPATED REVENUE, COUNTY SERVICE AREA NO. 25

Public Works is in receipt of checks in the amount of \$1,733.75 for reimbursement of utility trench repair work on View Point Road, County Service Area No. 25. The checks are from Pacific Gas and Electric in the amount of \$1,106.75 and Soquel Creek Water District in the amount of \$627.00 for a total of \$1,733.75. The County Service Area representative has requested that these monies be deposited into the County Service Area No. 25 account, Budget Index 622425, Subobject 2384.

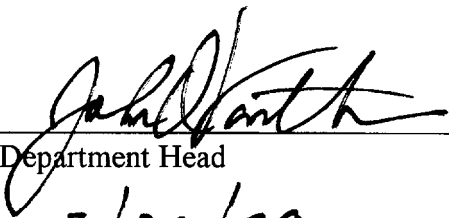
