SUBJECT: PROPOSED NEW STOP SIGNS

Members of the Board:

The Department of Public Works is recommending your Board's approval of several new stop sign locations in north and south county. The stop signs proposed in the south county are to be located in the **Lakeview** residential area. Two of the new stop signs would be located on the Cambridge Drive approaches at Crestwood Drive and Kingston Drive. In addition, a third stop sign is proposed at the Crestwood Drive approach at **Lakeview** Road. All three locations meet stop sign warrants from the State Traffic Manual. A map of the proposed stop sign locations is attached for your Board's review.


Additionally, our department has recently installed multi-way stop signs in the north county at the East Zayante Road and Valley View Drive intersection. This action was undertaken to improve the intersection operation due to stopping sight distance restrictions. We are asking the Board to adopt the multi-way stop signs into the County Code to provide permanent multi-way stop signs at this location. A map of the multi-way stop sign location for the East Zayante Road and Valley View Drive intersection is also attached for your Board's review.



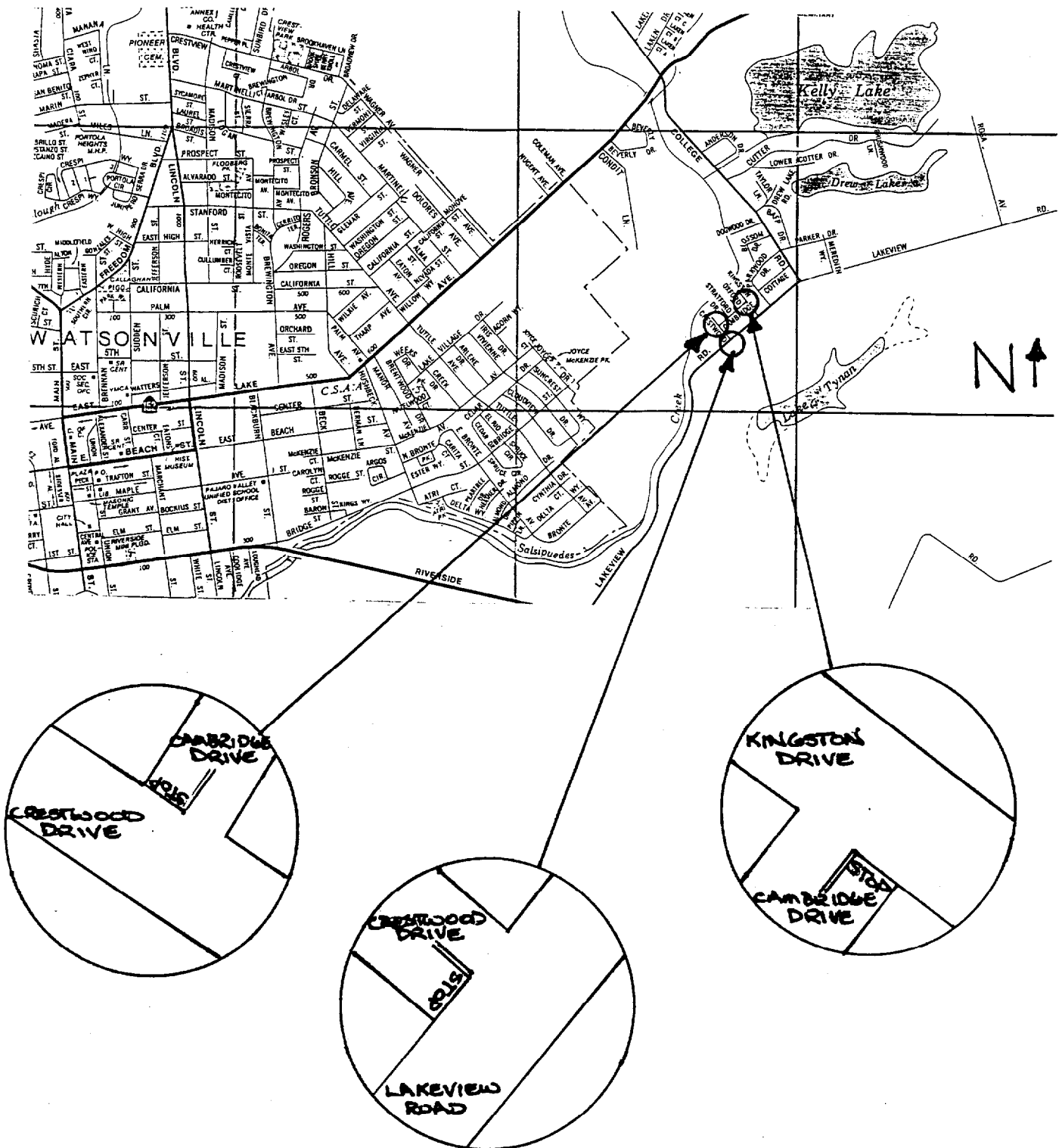

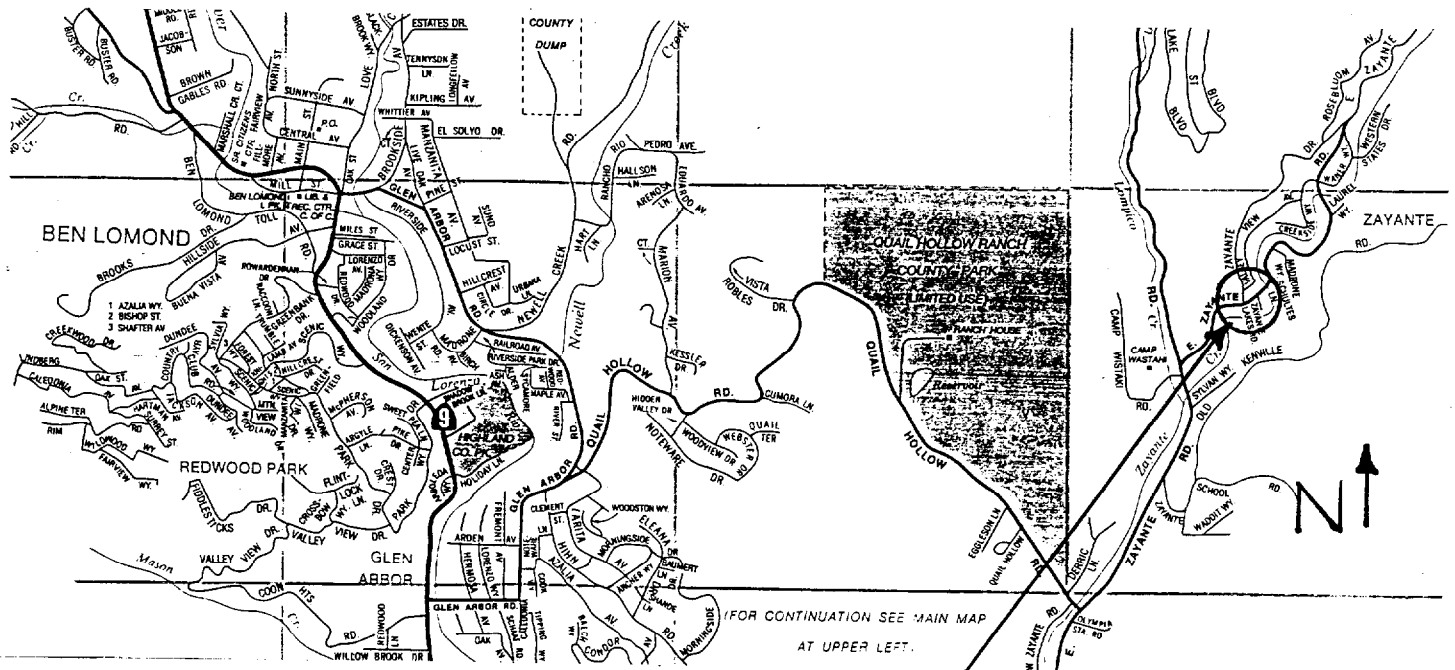
