SANTA CRUZ PORT DISTRICT - OCEAN RESCUE SERVICE

Dear Members of the Board:

This letter provides background on a financial problem concerning the Port District's Ocean Rescue Program and recommends that your Board approve a Contingency Transfer in the amount of \$33,000 to correct a good faith misunderstanding between the County and the Port District regarding the distribution of funds from the Supplemental Allocation Fund for the 1997-98 and 1998-99 fiscal years.

Background

During the 1993-94, 1994-95, 1995-96 and 1996-97 fiscal years the Santa Cruz County Port District received an allocation in the amount of \$33,000 for its Ocean Rescue Program from the Supplemental Allocation Fund which was authorized for Santa Cruz County following the State property tax shift of 1993-94. While the Supplemental Allocation Fund ended in 1996-97, as a result of a misunderstanding the Port District continued to budget funds from this source for 1997-98 and 1998-99. As result the District is now short a total of \$66,000.

We have met with the staff of the Port District regarding the problem and have agreed that there was a good faith misunderstanding regarding the funds in question and that the County would share in the solution to the problem. In this regard we agreed to recommend to your Board that the County provide the District with an allocation of funds in the amount of \$33,000 which is equal to half of the historic problem. The Port District has filed a request for funds for 1999-00. A recommendation on the Port District's request for 1999-00 will be included in the 1999-00 Proposed Budget.

Recommendation

At this time it is recommended your Board approve the attached Transfer of Funds from General Fund Contingency in the amount of \$33,000 for the benefit of the Santa Cruz Port District's 1997-98 and 1998-99 Ocean Rescue Program and direct the Auditor-Controller to pay the funds to the Port District upon the filing of the appropriate claim.
