REIMBURSEMENT FOR COMPUTER-BASED TRAINING SYSTEM FOR THE SHERIFF'S OFFICE CABRILLO COLLEGE DIVISION

Dear Members of the Board:

The Commission on Peace Officer Standards and Training (POST) has offered California law enforcement agencies a fully reimbursable multimedia computer system dedicated to state training goals and requirements. In an effort to take advantage of new technologies and to reduce costs, POST has agreed to provide selected training on compact discs and will provide a multimedia computer system, at no cost to the County, to expedite and realize law enforcement training mandates.


As your Board may recall, at the meeting of February 9, 1999, you approved the purchase of a POST multimedia computer system for the Personnel and Training Division of the Sheriffs Office. The Commission on POST has now agreed to provide the Sheriffs Office with the funds to purchase another system to be used at the Sheriffs Office Cabrillo College Division. The Sheriffs Office inherited an existing training computer from the Cabrillo College Police Department, however, this system requires upgrading or it will be non-functional. The current system does not have the capability to run upcoming programs through CDROM that are needed to continue the localized in-service training we provide for the half time security officer and the Sheriffs Office staff on campus. The purchase of the POST multimedia computer system will facilitate all POST CDROM training, as well as, facilitate the in-house TMS program. The POST multimedia computer system will greatly increase the efficiency and productivity across the board for Sheriffs Office training with no net County cost.

POST has provided a vendor, Computer Support Associates, based in Los Angeles, who will provide a multimedia computer system that meets POST specifications, at the reimbursable purchase price of \$2,894.40, including tax and shipping.

It is therefore recommended that your board:


1. Adopt a resolution accepting unanticipated revenue in the amount of \$2,894.40 as represented in the attached AUD-60 from the State Commission on Peace Officer Standards and Training for the purchase of a multimedia training system.
2. Authorize the Sheriffs Office Cabrillo College Division to purchase one computer-based multimedia training system in an amount not to exceed \$2,894.40.


