RE: APPROVE FIXED ASSET PURCHASES AND RELATED BUDGET TRANSFERS FOR CHILDREN'S MEDICAL SERVICES PROGRAM AND MENTAL HEALTH PROGRAM

Dear Board Members:

The Health Services Agency requests approval to purchase two data servers of approximately \$3,400 each. The servers will improve the processing capability and performance of two HSA local computer networks, one used by the Mental Health and Children's Medical Services (CMS) offices at 12 W. Beach Street in Watsonville and the other located at the CMS Medical Therapy Unit (MTU) at Duncan Holbert school.

The cost of these purchases will be covered by existing funds within the CMS and Mental Health program budgets. The related \$6,800 budget transfer is attached. The State will share approximately 75% of the CMS portion of this purchase.

No new County funds are requested and there is no increase in net County cost as a result of this budget transfer.

It is therefore RECOMMENDED that your Board:

1. Approve the fixed asset purchase of two data servers in the approximate amount of \$6,800; and

2. Approve the attached AUD-74 transferring \$6,800 to the fixed asset accounts from the services and supplies account in the Children's Medical Services program and the Community Mental Health program.
