Subject: Adopt Resolution Accepting Unanticipated Revenue

On your February 2, 1999 agenda, your Board approved the use of projected savings out of the 1990 Series C Certificate of Participation Issue to acquire a personal computer LCD projector. Since then, the County Assessor has identified the sum of \$3,500 of AB 818 funding that can be substituted for the COP savings. The COP savings will be used to finance part of the 1999-00 proposed budget.

Therefore, it is recommended that your Board adopt the attached resolution accepting unanticipated revenue in the amount of \$3,500 and appropriating the same amount.
