REQUEST FOR TRANSFER OF APPROPRIATIONS FOR CHILD CARE PROGRAMS

Dear Members of the Board:

As your Board is aware, the Human Resources Agency contracts with the California Department of Education (CDE) to provide subsidized child care services to eligible families in Santa Cruz County, including those transitioning off cash assistance. The CalWORKs single allocation also includes funds for child care for participants still receiving cash aid and moving toward self sufficiency. At the time of FY98/99 budget preparation, the development of a three-stage child care program administered at the State level by two different agencies was still in process. As a result, HRA's child care appropriations must now be redistributed between different funding sources to meet fiscal requirements of programs.

As a result of final contract and allocation determinations, we are requesting a transfer of \$408,000 from Stage 1 child care to Stages 2 and 3.

IT IS THEREFORE RECOMMENDED that your Board:

Approve the attached Request for Transfer of Appropriations in the amount of \$408,000 per the attached AUD-74.
