SUBJECT: TROUT GULCH ROAD IMPROVEMENT PROJECT

Members of the Board:

The plans, specifications, and engineer's estimate for the subject project are now complete and presented here for your consideration and approval. The work provides for the widening of Trout Gulch Road between Valencia Street and Quail Run Road to provide a left-turn lane, bike lanes, curb, gutter, and sidewalk on the west side of Trout Gulch Road.


The engineer's estimate for this work is \$400,000, including contingencies. Sufficient funding is included in the approved 1998/99 Road Program from Aptos Area Road and Traffic Improvement Fees.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications and engineer's estimate and authorize calling for bids.
2. Set the bid opening for 10:45 a.m. on June 22, 1999.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ~~fifteen~~-day period beginning May 23, 1999, in accordance with the provisions of Public Contract Code Section 20392.



Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than **10:30 a.m., June 22, 1999**, and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on County road in accordance with the specifications therefor, to which special reference is made, as follows:

This project involves the widening of Trout Gulch Road between Valencia Street and Quail Run Road. Construction includes installation of aggregate base, asphalt concrete, drainage structures, retaining structures, curb, gutter and sidewalk.

The successful bidder shall furnish a payment bond and a performance bond.


The contractor shall possess a Class A license at the time that this contract is awarded.
