ADOPT RESOLUTION TO IMPLEMENT VARIOUS CLASSIFICATION AND SALARY ACTIONS

Dear Members of the Board:

On January 26, 1999, your Board approved a reorganization plan for Substance Abuse and Mental Health Administration that consolidated administrative components of these two divisions of the Health Services Agency. This plan included studying a vacant Senior Departmental Administrative Analyst for reclassification as a lead clinical position for substance abuse services. The classification study is completed and recommends the establishment of a new classification titled Substance Abuse Program Manager. The study further recommends placement of the Substance Abuse Program Manager at salary range LL (\$3572-\$4763 monthly) and designate the position as Middle Management.

Two changes in title for job classes are recommended. In POSCS the title of Recreation Services Supervisor and Program Manager- POSCS does not reflect the scope of responsibility and has caused some confusion with the public in terms of reporting responsibilities. It is recommended to change the titles to Recreation Coordinator and Recreation Supervisor respectively to keep the series consistent. This change does not reflect any changes to job duties, knowledge and abilities, minimum qualifications or salary.

The extra help class of Seasonal Produce Inspector is recommended for abolishment. The Personnel Department has reviewed this class with the department to secure agreement to delete the class.

The affected departments and employee organizations are in agreement with the actions described above.
