SUBJECT: LAUREL ROAD STORM DAMAGE REPAIR
PM 2.0, DSRNO. 99140; PM 0.35, DSRNO. 263
(EVENTS NO. 1046 AND 1155)

Members of the Board:

The plans, specifications, and engineer's estimate for the subject project are now complete and presented here for your consideration and approval. The work provides for the repair of road **slipouts** at two locations on Laurel Road that were damaged in major storms in 1995 and 1997. This project will provide for construction of a soldier beam pile wall at PM 2.0, and placement of rock slope protection at PM 0.35.

The project as presented is limited to those repairs included in the approved Damage Survey Reports (**DSR**), so as to return the damage sites to their original pre-disaster condition. The plans and specifications thus provide for a repair which essentially matches the existing roadway in the vicinity of the repair site, pursuant to the Federal Emergency Management Agency's (**FEMA**) approved scope of work and available funding. In those instances where the funding approved for the DSR falls short of the actual bid price, we will submit a supplemental funding request to cover the **full** bid cost of repair.


The engineer's estimate for this work is \$165,000 including contingencies. Sufficient funding for the project was included in the approved 1998/99 Road Program.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications, and engineer's estimate for the Laurel Road Storm Damage Repair Project and authorize calling for bids.

2. Set the bid opening for 10:45 A.M. on June 22, 1999.
3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten day period beginning May 29, 1999, in accordance with the provisions of Public Contract Code Section 20392.

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than **10:30 a.m., JUNE 22, 1999**, and at **10:45 a.m.** or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on County road in accordance with the specifications therefor, to which special reference is made, as follows:

This project involves the repair of storm damage by placing rock slope protection at Laurel Road PM 0.35, and the construction of a pile wall at PM 2.0.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class A license at the time that this contract is awarded. The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award. Pursuant to Section 1773 of the Labor Code, the general prevailing rate of wages in the District has been determined by the Director of the Department of Industrial Relations, and such prevailing rate of wages is listed in the State of California, Business and Transportation Agency, Department of Transportation's publication entitled General Prevailing Wage Rates, current edition, on file in the office of the Director of Public Works.
