SUBJECT: BUENA VISTA LANDFILL - MODULE 6 EXPANSION PROJECT

Members of the Board:

A set of plans and specifications for construction of the Buena Vista Landfill, Module 6 Expansion have been placed on file with the Clerk of the Board for your consideration and approval. The current Module 3 disposal area is projected to reach interim fill capacity in early 2000 at which time additional disposal capacity will be required. The Module 6 Expansion Project before you is necessary to provide for this added disposal capacity and the continuing operation of the Buena Vista Landfill.

Original plans called for the construction of the Module 4 disposal area next, but due to delays in completing the siting process for a temporary off-site soil storage area, Module 6 is being recommended for construction at this time. The Module 6 site is currently utilized for stormwater retention facilities and is therefore partially excavated. As a result, construction of Module 6 will require a much smaller volume of soil movement than Module 4 and no off-site soil storage. However, to accommodate this construction, soil excavated from Module 6 will have to be temporarily stored on top of the future Module 4 site. The excavated Module 6 soil will then have to be moved a second time to a future off-site soil storage area. Future costs associated with the double handling of soil excavated from Module 6 are not included in the engineer's estimate below.


The engineer's estimate for this project is \$1,050,000 including project contingencies. Sufficient funds have been included in the 1998/99 County Service Area 9C Solid Waste Budget, Landfill Expansion Reserve for this purpose.

It is recommended that the Board of Supervisors take the following actions:

1. Approve the plans, specifications and engineer's estimate for construction of the Buena Vista Landfill, Module 6 Expansion and authorize calling for bids.

- 2 . Set the bid opening for Tuesday, June 8, 1999 at 10:45 a.m.
3. Direct the Clerk of the Board to advertise the attached "Notice to Contractors" for ten consecutive days beginning May 10, 1999, in accordance with the provisions of the State Contract Act.



NOTICE TO CONTRACTORS

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than 10:30 a.m., June 8, 1999, and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on County landfill in accordance with the specifications therefor, to which special reference is made, as follows:

-BUENA VISTA DRIVE SANITARY LANDFILL EXPANSION, MODULE 6-
150 ROUNTREE LANE, WATSONVILLE, CA.

Bids are required for the entire work described herein.

The work to be done in general, consists of: Earthwork, including general earthfill, mass excavation, subgrade preparation, and placement of clay liner, granular drainage material, and protective operations layers; Construction of leachate collection pipe trench, including high density polyethylene (HDPE) pipe, pea gravel, and filter and cushion geotextiles; woven and nonwoven geotextiles, HDPE geomembrane lining, leachate collection sump and pump, tanks, pipelines, concrete drainage ditch, chain link fence, barrier fence; and such other items or details, not mentioned above, that are required by the plans, Standard Specifications, or these special provisions shall be performed, placed, constructed or installed.



The successful bidder shall furnish a payment bond and a performance bond.
