
Re: ACCEPT UNANTICIPATED REVENUES

Dear Members of the Board,

During the June 1998-1999 budget hearings the Elections Department's proposed budget only included the costs of the November 1998 Election. The April and June Special Elections were not scheduled until after budget hearings. Although the cities of Santa Cruz and Scotts Valley are paying for the costs of the two special elections, additional funds must be appropriated in the Election Department budget. Additional funds must also be appropriated for the higher than anticipated costs of the November 1998 election.

The Special City of Santa Cruz election held on March 2, 1999, the City of Scotts Valley election held on June 8, 1999, and the higher than anticipated costs of the November 1998 election increased the department's extra help and overtime charges by \$55,000. The City of Santa Cruz was billed and has paid their costs. The City of Scotts Valley will be billed for the costs of their election. The schools, cities and special districts have each paid their proportionate share of the increased costs of the November 1998 Election. The total unanticipated revenues from these three elections exceed \$55,000.

It is therefore **RECOMMENDED** your Board adopt the attached resolution accepting and appropriating unanticipated revenues in the amount of \$55,000 from the schools, cities and special districts for the costs incurred while conducting their elections.
