SET PUBLIC HEARING TO CONSIDER IN-HOME SUPPORTIVE SERVICES CONTRACT AMENDMENT

As you may recall, the Human Resources Agency contracted with Addus HealthCare Inc., of Chicago, Illinois to provide In-Home Supportive Services (IHSS) during FY 98/99. In accordance with the California Department of Social Services (CDSS) Manual of Policies and Procedures (MPP) Section 23-622, the County has the option of renewing the IHSS contract for a period of one year, to provide services in FY 99/00.

Based on the contractor's satisfactory performance during FY 98/99, the Human Resources Agency recently entered negotiations with Addus to exercise the one-year renewal option. HRA and Addus have agreed on mutually acceptable terms for extension of the contract through June 30, 2000, and are currently preparing a contract amendment for your Board's consideration on June 22, 1999.

Under the provisions of CDSS MPP Section 23-625, a public hearing is required prior to your Board's approval of the IHSS contract amendment. Therefore, at this time HRA requests that your Board schedule a public hearing on the June 22 agenda for this purpose.

IT IS THEREFORE RECOMMENDED that your Board:

- 1. Direct the Human Resources Agency Administrator to report back on June 22, 1999 with a proposed amendment to renew the In-Home Supportive Services contract with Addus HealthCare Inc., for the period of July 1, 1999 through June 30, 2000; and
- 2. Direct the Clerk of the Board to schedule a public hearing on the proposed IHSS contract amendment on the morning agenda of June 22, 1999, and to provide appropriate notice to the public.
