SUBJECT: REDWOOD DRIVE SLIDE REPAIR PROJECT
COUNTY SERVICE AREA NO. 33, (2ND DISTRICT), DSRS 99061 AND 05731

Members of the Board:

The plans, specifications, and engineer's estimate for the subject project are now complete and presented here for your consideration and approval. The work provides for construction of a mechanically stabilized earthwall and restoration of the existing roadway to repair the 60 foot slide located at 3433 Redwood Drive, P.M. 2.2, which occurred in the storms of 1995.

The engineer's estimate for this work is \$107,900, including contingencies. Sufficient funding is included in the County Service Area No. 33 budget to cover these expenditures.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications and engineer's estimate and authorize calling for bids.
2. Set the bid opening for August 3, 1999, at 10:45 a.m.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning June **19, 1999**, in accordance with the provisions of Public Contract Code Section 20392.



Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than 10:30 a.m., August 3, 1999 and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for a slide repair project on Redwood Drive (CSA #33) in accordance with the specifications therefor, to which special reference is made, as follows:

**REDWOOD DRIVE (CSA #33)
SLIDE REPAIR PROJECT**

The work to be done consists, in general, of constructing a 1,200 square foot cellular confinement system including drain installation, backfill, asphalt dike, and erosion control.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class A license at the time this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award. Pursuant to Section 1773 of the Labor Code, the general prevailing rate of wages in the District has been determined by the Director of the Department of Industrial Relations, and such prevailing rate of wages is listed in the State of California, Business and Transportation Agency, Department of Transportation publication entitled General Prevailing Wage Rates, current edition, on file in the office of the Director of Public Works.
