## ABC GRANT: ADOPT RESOLUTION FOR CHILD ABUSE TREATMENT SERVICES (CATS) COMPONENT AWARD

Dear Members of the Board:

As you know, the Human Resources Agency (HRA) has been awarded a two-year grant from the Office of Child Abuse Prevention (OCAP) and the Governor's Office of Criminal Justice Planning (OCJP). HRA has provided your Board with copies of the grant proposal and supplemental budget update reports. The purpose of this letter is to ask your Board's approval of the attached resolution authorizing the HRA Administrator to sign and approve the portion of the grant award which pertains to the Child Abuse Treatment Services (CATS) component of ABC. This component is administered by OCJP and requires execution of the grant award agreement separately from OCAP. As described in previous reports to your Board, the OCJP CATS component provides a total of \$200,000 to HRA to provide treatment services to children up to age 18 who have been victims of child abuse and neglect. Appropriations for these grant funds are included in the County Administrative Officer's (CAO) proposed FY 1999/2000 budget.

IT IS THEREFORE RECOMMENDED that your Board adopt the attached resolution authorizing the Human Resources Agency Administrator to sign and approve the Grant Award Agreement with the Governor's Office of Criminal Justice Planning for the Child Abuse Treatment Services (CATS) component of the Answers Benefiting Children (ABC) program.

WHEREAS the County of Santa Cruz agrees to provide all in-kind or cash matching funds required for said project (including any amendment thereof) under the CATS Program and the funding terms and conditions of OCJP and that the cash match, if any, will be appropriated as required; and

WHEREAS, it is agreed that any liability arising out of the performance of this Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and OCJP disclaim responsibility for any such liability.

WHEREAS it is agreed that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.

NOW, THEREFORE BE IT RESOLVED AND ORDERED that the Human Resources Agency Administrator of the County of Santa Cruz is authorized, on its behalf, to submit the attached proposal to OCJP and is authorized to sign and approve on behalf of the Santa Cruz County Board of Supervisors the attached Grant Award Agreement including any extensions or amendments thereof.
