SUBJECT: FREEDOM BOULEVARD AT SOQUEL DRIVE SIGNALIZATION PROJECT

Members of the Board:

The plans, specifications, and the engineer's estimate for the subject project are now complete and presented here for your consideration and approval. This project provides for the signalization of the Freedom Boulevard at Soquel Drive intersection with protected left turn lanes and an exclusive right turn lane on Freedom Boulevard, two bus pull-outs, and standard sidewalk and drainage improvements.

The engineer's estimate for construction of this project is \$290,000, including contingencies. Funds for the work are proposed within the 1999/00 Road Budget using CSA No. 9 Signal and Lighting revenues, the Aptos Transportation Improvement Fees (TIF), and the Aptos Roadside Improvement Fees (RIF).

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications, and the engineer's estimate and authorize calling for bids.
2. Set the bid opening for August 3, 1999, at 10:45 a.m.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten day period beginning June 27, 1999, in accordance with the provisions of the Public Contract Code, Section 203 92.


