SUBJECT: 1999/2000 SLURRY SEAL PROJECT FOR VARIOUS LOCATIONS

Members of the Board:

Presented here for your consideration and approval are special provisions and the engineer's estimate for the 1999/2000 Slurry Seal Project. This project proposes to slurry seal 12 dual lane miles of County maintained roadway.


The engineer's estimate for construction of the 1999/2000 Slurry Seal Project is \$158,900. Sufficient funds are available in the 1999/2000 Road Budget to cover this expenditure.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the special provisions and engineer's estimate and authorize calling for bids on the 1999/2000 Slurry Seal Project.
2. Set bid opening for 10:45 a.m. on August 3, 1999.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning June 27, 1999, in accordance with the provisions of the Public Contract Code Section 20392.



NOTICE TO CONTRACTORS

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than 10:30 a.m., August 3, 1999 and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on various county roads in accordance with the specifications therefor, to which special reference is made, as follows:

**1999/2000 SLURRY SEAL PROJECT
VARIOUS LOCATIONS**

The work to be done consists, in general, of placing type II slurry seal coating on various County roads.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class A license at the time this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award. Pursuant to Section 1773 of the Labor Code, the general prevailing rate of wages in the District has been determined by the Director of the Department of Industrial Relations, and such prevailing rate of wages is listed in the State of California, Business and Transportation Agency, Department of Transportation publication entitled General Prevailing Wage Rates, current edition, on file in the office of the Director of Public Works.
