Included in the 1999/00 Redevelopment Agency and Public Works budgets are funds for the construction of the subject roadway, roadside, street lighting, landscaping, and drainage improvements.

The plans, specifications, and estimate have been completed for the subject project, and are presented here for your consideration and approval. The total engineer's estimate for this project is \$1,563,500.00 including contingencies and administration. Sufficient funds are available for this project.

It is therefore recommended that the Board of Supervisors take the following action:


1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids.
2. Set bid opening for 10:45 a.m. on July 20, 1999, in the office of the Director of Public Works.
3. Direct the Clerk of the Board to advertise a "Notice to Contractors" for a 10-day period beginning June 27, 1999, in accordance with the provisions of Public Contract Code Section 20392.

- 4. Direct Public Works to return to your Board on August 3, 1999, with the results of the bid opening and a recommendation on the award of the contract.


