SUBJECT: SUNSET BEACH WATER MAIN EXTENSION PROJECT ASSESSMENT DISTRICT, SAND DOLLAR BEACH REFUNDING REASSESSMENT DISTRICT, AND PLACE DE MER REFUNDING REASSESSMENT DISTRICT

Members of the Board:

Your Board adopted Resolution of Intention No. 236-97 on May 20, 1997, for the formation of the Sunset Beach Water Main Extension Project Assessment District. Changes and modifications to the original engineer's estimate were adopted on February 2, 1999, in order to finance higher than expected construction costs. The Assessment Attorney, Mr. Robert Haight, is recommending that the issue of the construction bonds for the Sunset Beach Water Main Extension Project be combined with a refunding of bonds for the Sand Dollar Beach and Place De Mer Assessment Districts. This will provide lower interest rates without extending the bond term of the previously issued bonds, thus creating a savings to be passed along to the property owners.

A resolution ordering changes and modifications is necessary to correct charges on a vacant parcel in the Sunset Beach Subdivision.

Presented for your consideration are appropriate resolutions to approve the sale of bonds for the new Sunset Beach Water Main Extension Project and the refunding of the Sand Dollar Beach and Place De Mer Assessment Districts.

As a separate item, the Santa Cruz Public Finance Authority will consider adoption of resolutions relating to purchase and sale of bonds for the subject assessment districts.

On June 8, 1999, your Board deferred adoption of a Resolution of Award of Contract to allow for issuance of bonds. It is now appropriate to adopt the Resolution of Award of Contract as part of today's actions.

It is therefore recommended that the Board of Supervisors take the following action:

- 2. Adopt the following resolutions for the Sunset Beach Water Main Extension Project Assessment District.
 - a) Resolution Ordering Changes and Modifications
 - b) Resolution Determining Unpaid Assessments and Providing for the Issuance of Bonds Pursuant to the "Improvement Bond Act of 1915"
 - c) Resolution Awarding Sale of Bonds, Approving the Form of Certain Contracts and Authorizing the Final Execution
