Members of the Board:

The Board of Supervisors received six bids for the subject project on June 15, 1999. The engineer's estimate was \$172,200. The low bid was received from WSP Trucking Co. of Alviso, California in the amount of \$170,975.04. All bids were checked and found to be in order.

Funding for the project was included in the approved 1998/99 Road Program. This project was partially funded by the Federal Emergency Management Agency (FEMA) under both the 1995 and 1997 storm event. This work will complete the final and remaining 1995 sites thus allowing a final report of damage completion to FEMA.

It is therefore recommended that the Board of Supervisors take the following action:

1. Accept the low bid of WSP Trucking Co. in the amount of \$170,975.04 and authorize award of the contract.

2. Authorize the Director of Public Works to sign the contract on behalf of the County.


