APPROVE JTPA CONTRACT FOR PY99/2000 WITH ARBOR, INC. TO PROVIDE ADULT ON-THE-JOB TRAINING (OJT) SERVICES

Dear Members of the Board:

n May 27, 1999, the Interim Workforce Investment Board/Private Industry Council approved its Evaluation Committee's recommendations for Program Year 99/2000 including the ARBOR contract for Otl-the-Job (OJT) services. The purpose of this letter is to seek your Board's approval of the contract with ARBOR and to authorize the Human Resource Agency Administrator to sign the contract.

The goal for OJT participants is permanent unsubsidized employment which will increase their economic self sufficiency. The contract will also require ARBOR to work with CareerWorks to implement a seamless transition for participants into the Workforce Investment Act. Funding for this activity are available in the JTPA budget. There is no cost to the County.
