Members of the Board:

The plans, special provisions and engineer's estimate for the Whitehouse Creek Road Storm Repair Project are complete and presented here for your consideration and approval. The project provides for scarifying, grading and shaping, then placing and compacting three inches of 1-1/2 inch rock for 1.3 miles of Whitehouse Creek Road.


The engineer's estimate for the Whitehouse Creek Road Storm Repair Project is \$58,000. Sufficient funds are available in the County Service Area No. 18 budget to cover this expenditure.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, special provisions, and engineer's estimate and authorize calling for bids.
2. Set bid opening for 10:45 a.m. on August 24, 1999.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten day period beginning August 8, 1999, in accordance with provisions of the Public Contract Code Section 20392.



NOTICE TO CONTRACTORS**

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than 10:30 a.m., August 24, 1999 and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for a storm damage repair project on Whitehouse Creek Road in accordance with the specifications therefor, to which special reference is made, as follows:

**WHITEHOUSE CANYON - CSA #18
WHITEHOUSE CREEK ROAD
STORM REPAIR PROJECT**

The work to be done consists, in general, of scarifying the top 3 inches of 1.3 miles of roadway, grading and shaping, then placing and compacting 3 inches of 1.5 inch crushed rock.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class A license at the time this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award. Pursuant to Section 1773 of the Labor Code, the general prevailing rate of wages in the District has been determined by the Director of the Department of Industrial Relations, and such prevailing rate of wages is listed in the State of California, Business and Transportation Agency, Department of Transportation publication entitled General Prevailing Wage Rates, current edition, on file in the office of the Director of Public Works.
