
SUBJECT: COUNTY SERVICE AREA NO. 50, THE VINEYARD (QUAIL DRIVE)  
ROAD BUMPS (3RD DISTRICT)

Members of the Board:


The residents of County Service Area (CSA) No. 50, The Vineyard have submitted an application and Petition of Affirmation signed by 58% of the residents for the installation of road bumps. The affected area is shown on the attached map. The installation of two road bumps is necessary to adequately control the speed of vehicles on Quail Drive within the CSA. The Public Works Department has also received letters from the California Department of Forestry and the Bonny Doon Union Elementary School District in support of the road bumps; these letters are required by the Road Bump Policy which was approved by your Board on May 11, 1993.

The residents of the CSA have complied with all the provisions of the Policy and the road meets all the eligibility requirements for placement of road bumps. The Policy requires approval by the Board of Supervisors prior to the placement of the bumps. Sufficient funds for the installation of the bumps are available in the CSA No. 50, The Vineyard budget.

It is therefore recommended that the Board of Supervisors adopt the attached resolution authorizing the placement of two road bumps on Quail Drive within CSA No. 50, The Vineyard.

WHEREAS, on May 11, 1993, the Santa Cruz County Board of Supervisors approved a policy and Design Criteria for the placement of road bumps on County maintained roads and within County Service Areas; and

WHEREAS, the residents of County Service Area No. 50, The Vineyard have submitted an application along with a Petition of Affirmation signed by 58% of the residents requesting the installation of two road bumps on Quail Drive; and

WHEREAS, the California Department of Forestry Fire District and the Bonny Doon Union elementary School District have submitted letters in support of the road bumps; and

WHEREAS, the residents of County Service Area No. 50, The Vineyard, have complied with all the provisions of the Road Bump Policy; and

WHEREAS, the Road Bump Policy requires approval by the Board of Supervisors prior to placement of the bumps;

NOW, THEREFORE BE IT RESOLVED AND ORDERED that two road bumps be installed on Quail Drive within County Service Area No. 50, The Vineyard in conformance with the Road Bump Policy and the Road Bump Design Criteria.

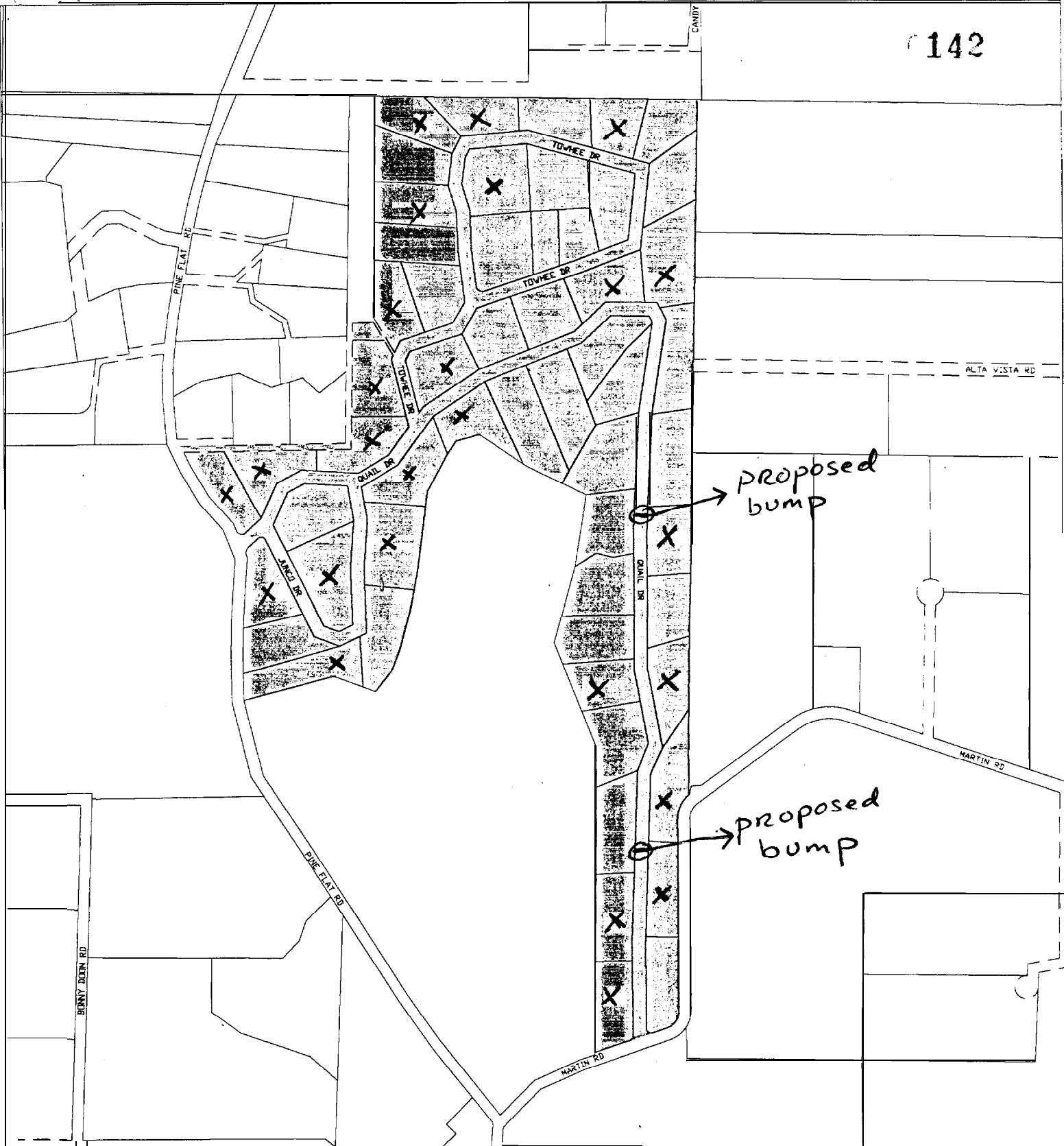

Residents of Quail Drive, located between Pine Flat Road and Martin Road, Bonny Doon area of Santa Cruz County have requested the consideration of the Santa Cruz County Fire Department to allow the installation of "Speed Bumps" on and along Quail Drive to assist in the reduction of vehicle speed.


The Santa Cruz County Fire Department has reviewed this request and while "Speed Bumps" are not encouraged, we will accept the installation of such "Speed Bumps", if they meet minimum "Installation Guide" recommendations as attached and installation is kept to minimum to allow expedient response of emergency equipment.

- The maximum height shall not exceed three inches (3") in height at the center.
- The minimum depth shall be no less than eighteen inches (18") at the base.
- All Speed Bumps shall be painted either Bright White or Safety Yellow for visibility.
