JOSE AVENUE INTO THE COUNTY MAINTAINED ROAD SYSTEM


Members of the Board:

On December 2, 1996, the parcel map for MLD 93-0160 was recorded. The developer of the project completed construction of the required improvements on January 11, 1999. The Public Works Department inspected the constructed improvements and found that they are complete and acceptable.

In order for the County to assume maintenance responsibilities for Parcel "A," it will be necessary for your Board to formally accept Parcel "A" into the County Maintained Road System.

It is therefore recommended that the Board of Supervisors adopt the attached resolution accepting Parcel "A" along the northwest side of Jose Avenue into the County Maintained Road System.

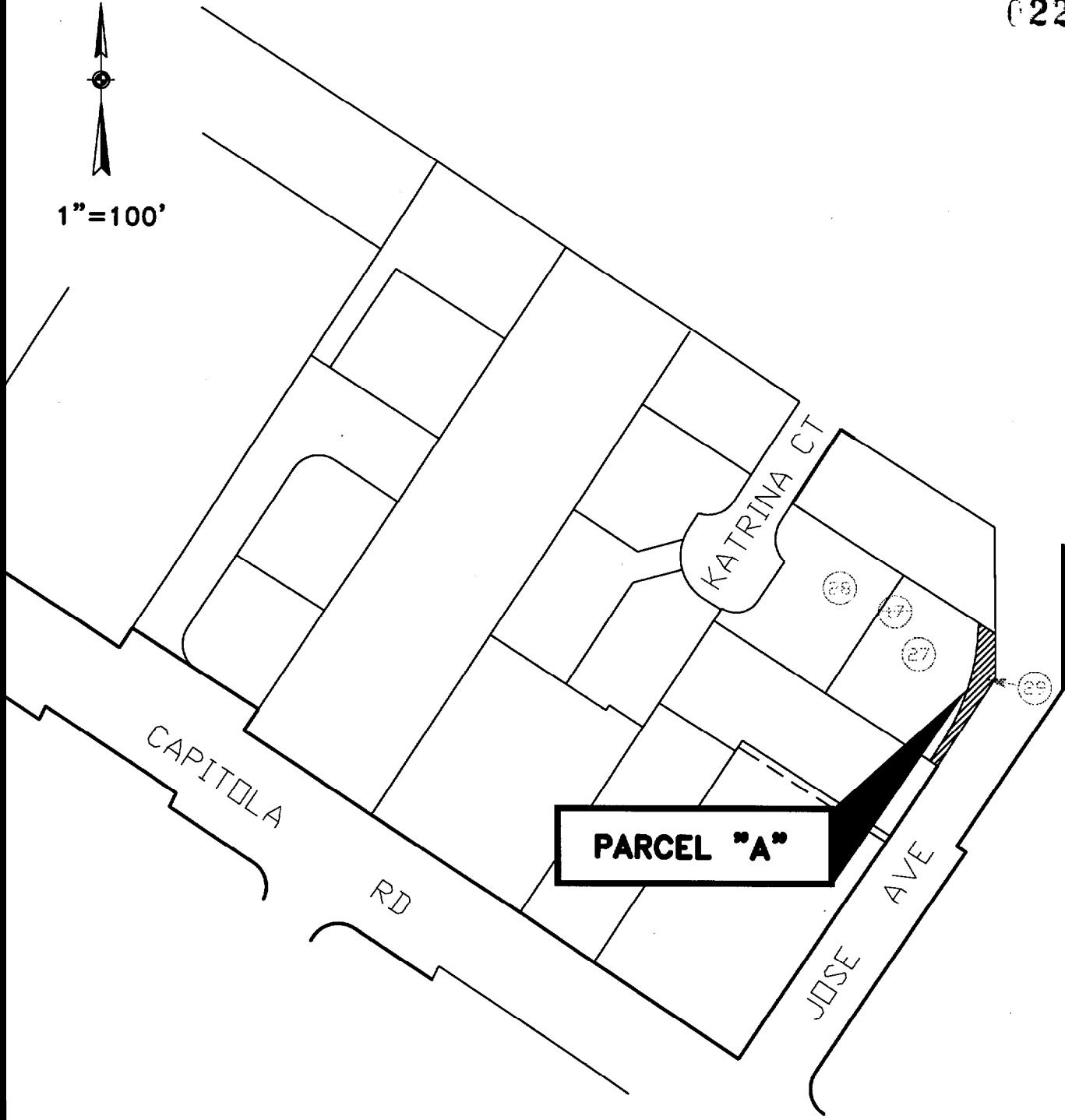
